

MEMORANDUM

August 4, 1968

TO: MR. GARRISON, DISTRICT ATTORNEY

RE: Frontiers Establishment Publishing Co. Representative

On the above date I received a telegram (see attached) requesting that I telephone Mr. HERVE LAMARRE (using a cover name of MARIE HERVE in the telegram). I did so at 6 PM Los Angeles time and had a conversation with Mr. LAMARRE, who represents the publishing company of FRONTIERS ESTABLISHMENT 18, Cours des Bastions, Geneva, Switzerland. I reached him at phone number 870-0200 in Paris (note: the number in the telegram is inaccurate.)

In response to a letter which I had sent MR LAMARRE and which he had received three days before our conversation he told me that a representative of FRONTIERS ESTABLISHMENT CO. would be in the United States on Thursday, August 8, 1968, and would be able to meet you on Saturday, August 10 or Sunday, August 11. The representative will not be MR LAMARRE himself, however I asked if I had already met this person and he replied, "Yes." This, I would suppose, will be MR PHILLIPE\* (No last name given) who is mentioned in earlier memos pertaining to my recent trip to France and Switzerland of May 21, 1968 to June 25, 1968.

MR LAMARRE told me that the book entitled "THE PLOT" (Fr. title "L'AMERIQUE BRULE") by JAMES HIBBURN has sold extremely well in its earliest days of publication in Europe. It is scheduled to be released in English in Great Britain as of September 1, 1968. He continued to say that in response to the questions I asked in my letter his representative will give you the relevant information.

1 The questions I asked in my letter (as you had requested) were:

- 2 a) In the case of the mention of one name, "FERGUSON", we  
3 have found some interesting corroboration. If you have  
4 any other details on this person or his involvement could  
5 you send them to us immediately?
- 6 b) Concerning the names of the men you have mentioned of  
7 those who took part in the plot, could you send us any  
8 details or information to show exactly when, if indeed,  
9 they were inside the limits of New Orleans (Orleans Parish)  
10 especially if any portion of the plot was carried out in  
11 that jurisdiction?
- 12 c) Could you send our office any details at all regarding  
13 the conspiratorial acts committed by the men we discussed  
14 particularly in the case of CLAY L. SHAW?
- 15 d) Could you send any details regarding meetings held by  
16 Chief Jesse Curry, DPD, with the others named in our  
17 discussions?
- 18 e) Concerning MR R.C. Could you send us his address as it  
19 was in Dallas or Houston, Texas in 1963? Could you send  
20 us the details of place and time during which meetings  
21 were held in these locations?
- 22 f) Concerning a tape recorded interview with a New York girl  
23 (estimated length of interview 15 minutes) which you had  
24 intended to have for me for my return trip to the United  
25 States, could you send that to me?
- 26 g) Would you like me to do anything to aid you in finding  
27 a publisher or distributor for the book in the United States  
28 or have you already made arrangements for that?

29 MR LAMARRE said that I should leave word with the law firm  
30 of COUDERT BROS., NEW YORK, NEW YORK, on Thursday as to where I  
31 can be reached in New Orleans. He asked that I leave the appropriate  
32 phone number at that office for MR FIDUCIARE WENNER and use my  
first name (Steve) only. I told him I would do this and would try  
to arrange a meeting between his representative and the District  
Attorney for the weekend of August 10 and 11th.
