(Ethridge?) Moday is April 12, 1968. My name is John Eddy Eskridge. On Monday before Dr. King was shot, there was a man over there where I worked at, he told me that Dr. King, uh, was going to get shot

when he come back to Memphis.

What was the man's name?

His name was Walter.

Q. Is that his last name?

JEE.

No, that's not his last name. That is his first name. He said that he had received, uh, a telephone call from his cousin that night and they told him that, uh, that this - that, uh, er - they was working with the police department, and uh, er - and if King returned to Memphis to - er, uh - lead a march, they was going to put up a man<sup>1</sup> building uh - uh - to shoot him. So, on the follimowing that Thursday, when King did get killed, I returned to work er - uh on Friday morning, at 8:15 and he met me and uh, and uh told me that I told you that uh - that they was going to kill him. So I replied to him that, uh, it was not funny worth a damn, and you better be careful in uh, in uh, in uh, in uh what you are saying, or you may get arrested yourself. And that was all that was said.

Well, what is this man's full name?

I really don't know his full name. Ι JEE. Well, where does he work? Q. He works at Mickey's (Nixie?) warehouse. JEE. Mickey Warehouse? Q. Yes; Mickey warehouse. JEE. Is that Mickey Lumber Company? Q2. Well, it used to be Mickey Lumber Company, but it's a warehouse JEE. now. Where is it located? Q. It's 289 West Ollie. JEE. West what? Q. Ollie. OLLIE. JEE.

Q. OLLIE?

JEE. Right.

What's his job there? Q. Well, uh, he don't have no certain job. JEE. He's a general foreman, then, you would say? Q2. Well, uh, he's not a foreman, and uh - well, you could call him JEE. a foreman 'cause he don't do too much. He just mostly do ... You don't know his last name. You just simply know he's Walter. Q. That's all I know, is Walter. JEE. He still works there. Q. Oh, hes. He still works there. JWE. Does he own a part in the business? Q2. No, he don't own a part in the business. JEE. He just ... Q. In other words, his half-brother there is the manager of the JEE. warehouse. I see. What's his half-brother's name? Q. Danny Lee Meadows. JEE. METTERS? ହ୍-That's right. JEE. Would you spell it for the record? Q. METTERS. JEE. That's right. Q. That's the way I would spell it. That's right. JEE. Can you tell us again what Walter said. So he said well, I believe what he said, said, but I just don't believe that it - that it ever would happen in Memphis. Then, he said, well, you can't trust these people here in Memphis, says, they'll do most anything uh - uh that could happen. What were the names of the other black people who heard this Walter Q. say ... One was Timothy Carter. JEE. You know where Timothy Carter is now? Q. Briton. He live on Grenwich St. offa Sheriff. I just remember theretizes JEE. BRIT-Q. Briton. BRITON. But I wouldn't know exactly his number. If JEE. I'm not mistaken, it's in the 1500 block. And what about the other one. Q. This other fellow, he's a - he heard, uh, what he told me was on a JEE. Friday morning because we was working side by side, and he definitely heard him what he said, and -He heard Walter say it. Q. Yes, sir. He task heard him, that said, I told you he was going JEE. get killed. He heard him say this Friday following -**A.** After. That's right. JEE. That would be April 5. Q.

Uh, I told John about what happened, see, and uh, John uh, uh, he got his information from Mink. Q2. Did you know the other John's name who was present? JEE. No. Nick was his first name.
