On Fovember 29, 1963 the undersigned Detective's sent a letter to the Bolice epartment on intense, revas asking them for a complete character check on Norry I. lower, which came back stating that no arrest or criminal data could be found with that Pepartment. (A copy of this letter will be attached with this care file).

On recember 7, 1963 Assistant Chief of Detective's Lugene Butts wrote a letter to unil Peters, Inspector, San Intonio, Texas Folice Depart ent, which included a little more information concerning this case, since we had not recieved any word on the letter sent by the undersigned. On Dec. 10, 1963 Capt. But s. recieved a letter from Inspector reters stating that Dective T.T. Fenley had been assigned to the case, and would send a complete report on his findings. (These also will be attached to this case file). In the meantime investigation by the under i ned revealed that this subject had been in the bus Terminal in this Sity, after recieving this information we went to the Bus Terminal where we talked to one Don Locker who stated that this subject came into the Terminal on Londay Nov. 25, 1963 and purchased a ticket to St. Louis, Lo. At 5:45 /. that night when tooker called out over the michrophone that this bus was ready to leave this subject mot up and run out the door and down the alley. It was, revealed through coresponence that Parry 1. Fower resided at 108 W. University Avenue, Jan Antonio, Texas, and worked for Acme Meon Company in that City, he was employed by that company for about one year, and left the Company on December 12, 1962, and left a forwarding address of Gen. Delivery Juftberry Menila, west Virginia. He was born 4-5-43, 5'10" 180 lbs., and has a current Towa drivers license. We also learned that a Roser Brisch had worked with Harry lower, and knew that he owned a fifle such as was found here.

Through corespondance to the National Rifle Association we learned that they could not find anything in thier files refrence to the German Hauser U-8686 found in the Terre Haute House Hotel in this City on Nov. 26, 1963

This case is still under investigation by the undersigned Detective's.

14. Describe (List Persons https://icrost.il, etc.)-Received a letter from Capt. Eugene V. Butte of the above Police Dept. to run a character check on Harry L. Power. SEE COPY OF LETTER ATTACHED. I checked with Mrs. W.W. Ocablin of 127 University P3 22137 and she stated that she has lived at this address for 50 years and that she does not rout to aryone and does not know the person I was checking on. I than checked with Retail Credit and found that a Harry L. Power gave the address 108 Univer sity and that he had many bad debts on his record. I then called Mr. Worth Seeman in Austin Tex. DPS records Chief and had him run a check on the subject. He called back and stated that they had no record on the subject but that in July of 1962 a Harry L. Power who gave the address of 108 University tried to get a drivers license. He failed the test and did not apply again. He also gave so the following information. Power is 5'-10 1804 DOB 4-5-13 and is a painter by trade. He also had a valid Ioua drivers lic. at the time he tried. to got a Taxas Lic. No gave Acas Moon Co. 1301 W Milderbrand San Antonio Tox as his place of employment. I chacked and found that the owners is Don McNay. I talked to him about the subject and he told me that he left his company on Sept 12, 1962 and that he was a smart alock type person and a trouble maker. He told me that Power left town owing a lot of bills. He also teld me that cae of his workers had told him that the subject Power carried a card with the YCL. I added him what that was end he told me that this was THE YOUNG COMMUNIST LEAGUE. I acked him if he could remember who the party was and he said that he would try to find out. He called beek and told me that the man was Roger Dreach who is a artist and worked for him but now was working for the Rollins Outdoor Adv. Co. 2323 Broadway SA Tex He said that Dresch told him today when asked about the card that it looked real and had Power's name on the front along which the name THE YOUNG COMMUNIST LEAGUE. On the back of the card was some type of cath. Mr. Holley told me that the last time he heard from Power was when Power wrote for his W2 forms from Gen. Del. Taftberry, Manila W. Va. I called Mr. J Myer Cole agent in charge of the FBI Office are this the information and he had Mr. Mark Childs Agent, get in touch with me. Mr. Childe will have Capt. Butts interviewed by the FBI in Indiana to see if there is any more information and asked for us to continue our investigation.

Docember 10,2963: Continued investigation. Went to the address 108 University and talked to Mrs. H.J. Moore of Apt. 2 2. She told me that she and her husband have lived there for about 9 months and that no one by that name lived there since they have lived there. I then want to Rollins Outdoor Adv. Co and talked to Mr. Dresch. He told me that Power was a odd sort of person. That he had a warped out look on life. That he felt the world owed him a living and that there was nothing wrong with Communist's. He spoke free about Communists and about our type of Government. He don't remember Power saying anything about doing any harm to any Offical. His out lock was to go back to W. Va and take his rifle and go into the hills and stay there for the rest of his life.. HE WAS A TOP MARKSMAN going to the rifle range at least 2 or 3 times a week. The only other person that he knows he ran with is a boy named Charlie and that Charlie is Dig and Fat and works for a garage some where around Five Points. The eard that he carried was cream colored with dark blue or black letters. I then called Mr. Jack Colo camer of the apartment house at 108 University and asked him about the man and he did not know such about him but that he was married to a woman in the Air Force and that the was an Ex Army man and that they seemed to have a lot of family trouble and that he moved out around Sept. of last year and he has not heard from his cines.
