RESULTS OF INVESTIGATION

On ~~CONFIDENTIAL~~ who was in a position to furnish reliable information, stated that DOROTHY WILSON advised in 1957, that HELEN HOMÉ was turning over most of the business to WILSON. WILSON added that she believed HELEN HOMÉ wanted to be associated with the business only to the extent of receiving expense money and as a place to make luncheon dates.

DOROTHY WILSON, according to the informant, also advised that HELEN HOMÉ has a son, JOHN HOMÉ, who works for "AIA" in Washington, D.C., and whose wife works in "Navy Intelligence." WILSON continued with the information that JOHN HOMÉ's wife was being upgraded from a semi-secret position to a top secret position and that the authorities had informed her that she could not have this top secret position because of HELEN HOMÉ's association with WILSON. Too, WILSON advised JOHN HOMÉ's wife was told that it did not appear that she would get the top secret position if she could not be "cleared," and, if she could not be "cleared," they did not believe she was fit to hold her present position. WILSON said JOHN HOMÉ's wife was faced with dismissal, which would have been "frightful," except that she was expecting a child and was leaving in February anyway.

Information concerning DOROTHY WILSON, and HELEN HOMÉ WITTS' relationship to JOHN L. HOMÉ and association with DOROTHY WILSON has been set forth in a previous report in this matter.
