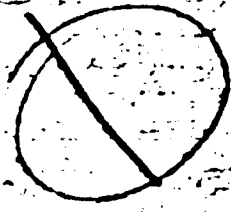
SUBJECT: LEE HARVEY OSWALD;

On 10-22-75 William Lawrence Robertson, 722 N. Winneka, Dallas, Texas, tel #946-9555, telephonically contacted the Dallas FBI office and advised he was in possession of a duplicate of the note which Lee Harvey Oswald brought to the Dallas FBI office a few days before the assassination of John F. Kennedy. Robertson stated that he was employed by Texas Law Enforcement Magazine, 608 N. St. Paul, Suite 620, Dallas, and that he would not furnish this note to the FBI.

Supervisor Geary was in office at time call was received and Geary also talked to Robertson. Geary made arrangements to interview Robertson at 9:00 AM, 10-23-75.

It should be noted that during course of conversation Robertson became loud and possibly was intoxicated.

At 1145 PM Robertson made another call to Dallas FBI and admitted he had been drinking and sounded extremely intoxicated. Robertson maintained he was in possession of aforementioned note.

7:35 p.m., 10/23/75, a telephone call was made to TOM KIMBLE, Dallas Morning News (newspaper), Dallas, Texas, telephone 745-8456, in response to KIMBLE's earlier inquiry of the FBI Office to the effect had the FBI Office on the evening of 10/22/75, been contacted by one BILL ROBERTS who claimed to have a copy of a note that had been delivered to the Dallas FBI Office by LEE HARVEY OSWALD. MR. KIMBLE asked if the Dallas FBI Office had been contacted by BILL ROBERTS who also used the name AL SMITH, JR. KIMBLE explained he was contacted during the evening of 10/22/75, by an individual claiming to be AL SMITH, JR., but on further inquiry the individual gave his name as BILL ROBERTS, 722 North Winnetka, Dallas, Texas, telephone 946-9555. KIMBLE said ROBERTS claimed he has a copy of the note purportedly delivered to the Dallas FBI Office in November 1963 and said the note is in a safe deposit box in care of ROBERT's wife in California.

KIMBLE said ROBERTS sounded like he had had too much to drink but pointed out ROBERTS' 88-year old mother came on the telephone and told KIMBLE her son served with LEE HARVEY OSWALD in the U. S. Marine Corps.
