Material relating to the assassination of JFK among the records of the Rockefeller Commission in the custody of NL consists of 12 file folders, less than 1 cu. ft., of the records of investigators Robert Olsen and James Roethe. The records include correspondence with Government agencies and experts on various aspects of the assassination, copies of depositions, lab reports, medical analyses, photographic analyses, copies of photographs, investigators' notes, Commission memoranda, and copies of published articles.

Two of the folders contain restricted material; one is marked "Confidential", the other is marked "Secret/Sensitive."

All of the material relating to the assassination that is marked recorded in the index to the Commission files has been located.

The only agency materials contained in this segment of the Commission files are from the Department of the Army (folder C), FBI (folders A, D, J) and the CIA (folders A-F). CIA materials are classified Confidential, Secret, Secret/Sensitive, and Secret/Eyes Only.
