<u>SYNOPSIS</u>					
<p>Examination of State records reveal that H.L.H. Products Inc., and H. L. Hunt Food Company are not incorporated in the State of Texas. Information regarding similiar name corporations is listed below. Attached are certified copies of corporation charters for the H. L. Hunt Foundation and the H.L.H. Fun & Food, Inc.</p>					
<u>DETAILS OF INVESTIGATION</u>					
<p>This investigation originated on October 9, 1964, upon telephone request by SA Wofford, Dallas Office, to determine if H.L. Hunt Food Company and H.L.H. Products, Inc. were incorporated in the State of Texas and any background information available.</p>					
<p>On October 9, 1964, interviewed W. G. Bowers III, Assistant Secretary of State, State Capital, Austin, Texas. A check of State records revealed that the H. L. Hunt Food Company and the H.L.H. Products Inc. are not incorporated in Texas.</p>					
<p>Certified copies of records regarding the HLH Fun & Food, Inc. and the H. L. Hunt Foundation were obtained and attached as they are related to H. L. Hunt.</p>

Hunt Oil Company; Delaware Corporation; 100,000 Shares Comm., NY; Registered Agent, Roy Lee; Registered Office, 700 Mercantile Bank Building, Dallas, Texas; With the latest amended certificate being filed October 15, 1956; President, H. L. Hunt; Secretary, Roy Lee; Vice President, Sidney Lathan; Secretary Treasurer, Roy Lee; Assistant Secretary Treasurer, W. B. Beeman; Assistant Treasurer, A. J. Kellog. All were listed with Dallas, Texas, addresses.

Hunt Foods Inc.; Delaware Corporation; Registered Office, Republic National Bank Bldg, Dallas, Texas; Registered Agent, C.T. Corporation System; Certificate of Withdrawal issued on 12-1-58. Mr. Bowers stated that he did not believe this corporation was related to H. L. Hunt.

Life Line Foundation, Inc.; Registered Office, 1220 Mercantile Securities Building, Dallas 1, Texas; Registered Agent, Ralph B. Shank; Designation of registered office and appointment of registered agent number 17,107239 is dated June 5, 1963; Charter approved, 6-19-63; President, H. L.
