I want to thank you and your gracious wife for your time and hospitality last Sunday when you allowed me and my sons to viasit and learn from you. In particular you willingness to share your experiences, knowledge and wisdom were helpful to me, and your kindness and understanding toward my boys are appreciated.

I was able to visit briefly with Jim Lesar at the AARC office later that week. I did not have time to pursue my wish to see Oswald's alleged murder weapon or CE 399, but I will work on Sue McDonough and the rules to be able to view them in time.

I have contacted Michael Hurwitz of Reynoldsburg, Ohio (southeast suburb of Columbus) and have requested a copy of his taped itnerviews with various personages in Dallas, including Oswald's landlady at the time of the assassination. Jim Lesar has agreed to have the tapes transcribed for your use and I will donate a copy of the tape to the AARC. I am also working on getting Mr. Hurwitz to write a signed statement regarding his ownership of two Manlicher-Carcano rifles that are very close in serial number to Oswald's alleged weapon and how Hurwitze obtained them (from Dallas' Deputy Police Chief).

Mr. Hurwitz, is, you might recall, the former Defense Department employee who had archives clearance in the early 1970's while investigating the My Lai massacre allegations for the military. He deals in collectables and has first option on various assassination memorabilia. He will be speaking in May, hopefully, to several classes of our students at Dublin High School.

When I returned home, I noticed that <u>Human Events</u> newspaper, a conservative weekly out of Washington, printed my letter to the editor, asking that this issue not be classified a "conservative vs. liberal" knee-jerk issue, but rather an issue of finding the truth, where possible, wherever the facts might lead.

We are looking for a place in the yard for the "Maryland quartz" my youngest boy found in your yard, and are combing the pine cones for seeds to plant. I know tht they nor I will forget our visit.
