

Dear Corky,

Your letter dated the 6th bears an 11th postmark. It came today. I'll respond in haste in the hope it can reach you Tuesday.

I have a date to speak on the 20th and next month on the 17. Otherwise, unless there is a medical need I do not see in the near future, I'm clear.

At this point my hunch is that it is better not to deal through the lecture bureau for flexibility and speed. They are like any other bureaucracy, inefficient.

There also is one other thing that should be considered. My blood tests are now down to every second week. My next is on the 23, then 3/8, etc. On Mondays.

I'd rather do it as soon as possible because I'm writing a new book and the more time passes the more pressure there will be.

Also, if what I'd say on JFK meets with approval, perhaps next semester they'd want something similar on the King case, which will have developed some by then. After one visit I may get to like Vegas.

And I suppose the blood testing could be done there and phoned in.

There are things I would like to discuss with you and the offer of a change of scene and a little relaxation are welcome.

The schools have a problem knowing who knows the subject and knowing who is a ripoff, as most are. There is little that can be done to meet this. Maybe some day I'll print up copies of the means the FBI last resorted to in pretended answer to my proof of perjury in a case against it. They attested that I could make this charge ad infinitum because I know more about the subject than anyone in the FBI. And the fink judge took it as an answer, too!

This reminds me if you can please ask the people to let me know as soon as they reach a decision I'd appreciate it because in the newest ~~case~~ case to get before a judge (one hasn't yet, one is on appeal) they blinked in the last minute and have promised to spend a week searching files they had already said held nothing. If they are honest I may hear as early as this coming week. This does not mean they'll deliver ~~anything~~ anything. I'll be away part of most of Wednesday but unless one of these other things comes to a head I won't be out of town until I leave for the speech on the 20th.
