a "certificate of citizenship".

I was under the impression
that since I am an American-born
citizen of the United States, my
daughter would also be a citizen of
the United States even though she
was born in another country.

I am certainly surprised and
pained to find out that she is
considered an alien.

In my wife's visa papers we
are as follows: husband - U.S.
wife - Russian
Daughter - U.S.

I was told that her Embassy-issued
birth certificate was all the proof of
her U.S. citizenship she would ever
require.


