The ACLU has since decided to represent me in the appeal and the Nader law group is representing my lawyer, Jim Lesar.


Because there is a question of individual rights I appreciate the referral to Mr. Glickman. But I am much more concerned about what I regard as the official subversion of our system of justice and the abuse of counsel.

I believe that as long as the government is immune in any and all offenses these practises will be resorted to more and more. I also believe that if some effort were to be made to end them, even if it did not succeed, the result will be that the government's people will be more reluctant to engage in the abuses.

In the litigation in question, other abuses, without reasonable doubt, include perjury and possibly its subornation. While I do not believe that any of the courts before which I have been will seriously entertain perjury charges, the effort itself should be ~~writ~~while and reduce resort to that abuse.

If I were younger and in better health I'd be exploring whether other of these many abuses are actionable.
