Meeting with Representative of French Deuxiene Bureau

Friday June 21, 1968 Club KAMA in the Latin Quarter of Paris Rue Dauphine.

On this date at approximately 11 Pm I was picked up by Herve Lamerre and intorduced to the man he had spoken about as "Phillipe." Phillips drove a white peugot, license 349 7 95. To drove to the Club Mana speaking about very uniportant things as we drove. I determined that Phillips had just returned from a trip to Now York and planned to go to the United States again in a "fortnight" which would be around the end of the first week of July. He would be going to San Jose California to examine a new nuclear energy plant there evidently owned by General! Electric.Co. His precialization was energy which had previously been concorned with the Cil industry and was now strategiacally changing its concentration to nuclear power. This change, Phillip explained later was due to the French government's desire to get in on the beginning of the newest processes for producing nuclear power which they felt would replace all other forms of energy within twenty years. It was their feeling that the American Oil industry would begin to feel the effects of the change within ten years and that they would soon begin making moves to overtake the control of the nuclear energy production which is primarily owned by General Electric.


The French have been at the mercy of the American Cil Industry for many years and the Small Mestern European Cil companies are so dependent on the American Cil economy that they are xixxy kixy struggling to maintain therselfes. One thing is sure, the American Cil Industry, which earns approximately \$4,000,000 per day sets the prices for the rest of the world. Russia which has been steadily gaining in their ability to produce oil has been profiting by the hight level of the price which is caused entirely by the American Cil Industry.

Lawarre had told be that it was Phillips who had been so instrumental in gathering information about the oil industry boole involved in the plot ggainst Kennedy although that was never really his dission and his cover was always in the field of Science related to the Oil Industry. At one time phillips had not with a san in Mexico who had been a part of the ambush group which murdered the President in Dealgy Plaza. This side trip for Phillips was directly connected with an attempt to gather information about the assassination although he had been in Mexico on other business. Fhillips had had this conference in a Hotel in Mexico city in approximately 1966.

Although Phillipe had never admitted to this meeting to me he did confirms in subtle terms, always being careful to qualify his statements as "his own personal opiilons", that he was aware of the Notel Luna, that it had been important meeting place for the assassination and in 1963 it had certain residents who were Cuban. It is difficult to state thing's which are understood from this type of discussion in a positively factual way. I found that Phillips did not want to tell things directly but that if an analogy or humorous metapher were suggested as a vehicle for discussion purposes he would follow along carefully allowing certain new information to be known. He suggested that the hotel (LUNA) had a "Cuban Band" and after that the analogy became one of discussing xxxxi musicians and " their instruments".

Phillips could not be mistaken for an American as 'he speeks with a strong Prooch account and is European in appearance possibly with some german blood.

Phillips discussed the French government's clan to try and elevate that their position with regard to their own oil industry over the next ten years but indicated that their sain interest at present was securing the lease or rights to produce nuclear energy; rights which are now in the hands of J.E. Phillips will be in San Joss seen and will contact as -- he agreed to speak to produce if it was desireable.


