DETAILS

SYNOPSIS

H. G. Joiner interviewed and advised that L. H. Oswald came to him at the Lone Star Cadillac Building, Dallas, Texas, seeking employment; that Oswald at that time gave the name of E. O. Cargill as a friend who also was seeking employment. Joiner placed the names L. H. Oswald and E. O. Cargill in his time book on the week ending 10-27-62. Neither subjects showed up for work. Efforts to locate E. O. Cargill in the Dallas area met with negative results.

DETAILS OF INVESTIGATION

Reference is made to my M/R dated 1-27-64 and to O/M of SA Kenneth J. Weisman, Resident Agent, Austin, Texas, dated 2-10-64.

Other Investigations

On 2-4-64 in a pre-arranged meeting at the Bonham High School, Bonham, Tex., interviewed Mr. H. G. Joiner who is a roofing contractor and who resides at 2134 Highway 75, North, Sherman, Texas. He stated that in October 1962 he was repairing the roof at the Lone Star Cadillac Building at 2311 Ross Ave., Dallas, Texas. He stated that sometime during the week ending 10-27-62 he was on the roof of the Lone Star Cadillac Building and that L. H. Oswald came on the roof and asked him, Joiner, for a job. Joiner stated that he told Oswald that he needed a local man, at which time Oswald said "Is Irving local enough?" Mr. Joiner stated he said that it was local enough and that he, Oswald, could have a job helping with the repairing of the roof. Mr. Joiner stated that Oswald said he did not have a car, but that he had a buddy who had a car and asked if

he could use him in helping on the roofing repair job. Mr. Joiner stated that he told Oswald that he and his buddy could have the job, at which time Oswald furnished the name of his friend, E. O. Cargill. He stated that he wrote the name "L. H. Oswald and E. O. Cargill" in his time book dated week ending October 27, 1962. He said that he asked Oswald for a telephone number where he could be contacted and Oswald stated that he did have a telephone where he was staying but that he did not know the number and that he would bring the number to him, Joiner, when he came to work the next day. Mr. Joiner advised that neither Oswald or Cargill ever showed up for work. He stated that since that time he has seen Oswald's picture over television and in the newspapers and he felt like this was the same person who approached him during the week of Oct. 27, 1962, while he was working at the Lone Star Cadillac roofing job. Mr. Joiner stated that he did not see E. O. Cargill and did not have any information re this subject; that at the time he was repairing the roof at the Lone Star Cadillac Building that he did not advertise for any extra help; that his working crew was all from Bonham, Texas, and that he was wanting a local man but that he did not advertise for such, and he stated he did not know how Oswald obtained information to come to him, Joiner, for employment.

Mr. Joiner further stated that since talking to reporting agent on 1-27-64, that someone had torn the names of L. H. Oswald and E. O. Cargill out of his time book and that he strongly suspects that it was his wife who did this. He stated that shortly after the assassination that he told his wife, whom he described as a very nervous person, about having the names of Oswald in his time book and that his wife became so upset that she had to be put to bed. However, he stated that when the Reporting Agent talked to him on 1-27-64 by phone that the names Oswald and Cargill were still in the time book and that he, Joiner, did not notice these names missing until shortly before this interview, on 2-4-64. Mr. Joiner furnished the remaining half of the page from the time book and was requested to contact his wife and ascertain if she did tear the names out of the time book and if she still had them in her possession. Mr. Joiner stated he would talk to his wife, however, he stated because of her nervous condition he felt that she would not tell him, if she had torn the names out of the time book. He stated he would notify the Dallas Office as soon as he talked to her. Mr. Joiner could furnish no further information.

On same date at Denton, Texas, interviewed Robert L. Oswald, brother of Lee Harvey Oswald re the name E. O. Cargill. Robert stated that he had never heard of the name E. O. Cargill and that he definitely has not heard Lee ever mention this name.

On 2-5-64 Mr. Joiner called the Dallas Office by phone and advised that he had approached his wife re the missing names out of his time book, at which time he advised that his wife said that she did not tear these names out and that she did not know what could have happened to these names. However, Mr. Joiner stated that he felt reasonably sure that his wife was responsible for the names being torn out of his time book.

The periods from Feb. 4 to Feb. 6, 1964, the following agencies and departments were checked in an effort to locate E. O. Cargill, with negative results:

Dallas Police Department; Dallas Sheriff's Office; Internal Revenue Service, Dallas; Irving, Texas, Police Department; Ft. Worth Police Department; Tarrant County Sheriff's Office, Ft. Worth; Texas Employment Office, Dallas; Texas Employment Office, Ft. Worth; Irving, Texas Water Department; Irving City Directory; Dallas City Water Department; Dallas City Directory; Ft. Worth City Directory; and Central Intelligence Agency, Dallas, Texas; FBI, Dallas Field Office.

Records at the Y.M.C.A, Dallas, Texas, revealed the name of William D. Cargill who was classified as a permanent resident, having moved into the Y.M.C.A. on 10-4-61, and lives there at the present time. Subject occupies Room 1202. On 2-5-64 the subject was interviewed at the Y.M.C.A. in Room 1202 and he advised that he did not know personally L. H. Oswald, other than what he had read in the paper and saw over television. William D. Cargill is 74 years of age and states that he lives in the Y.M.C.A. so that he can use the facilities of the Y.M.C.A. to retain his health. He stated that he did not know anybody by the name of E. O. Cargill,

In the M/R from RA Kenneth J. Wiesman, Austin, Texas, he advised that he checked the Texas Department of Public Safety, Bureau of Identification with negative results, also the State Traffic Violations Bureau and the State Welfare Bureau with negative results. The Texas Drivers License Bureau furnished the name of C. A. Cargill and gave his address as 9734 Abernathy St., Dallas, Texas, and listed his occupation as carpenter.

On Feb. 5, 1964, reporting agent talked with Inspector Kelley by telephone at which time Mr. Kelley advised that Mrs. Marina Oswald had been approached with the name E. O. Cargill and she at this time advised that she did not know this subject.

#### UNDEVELOPED LEADS

On advice of Inspector Kelley the Dallas Office is to have a National Agency check made in effort to locate E. O. Cargill. Also the Dallas Office is to interview a Mr. C. A. Cargill who resides at 9734 Abernathy St., Dallas, Texas, and whose occupation is a carpenter, in an effort to develop any leads re E. O. Cargill.

Austin Resident Agency is requested to check with the State Employment Commission at Austin to see if they have a record on E. O. Cargill.

The remaining portion of a page from H. G. Joiner's time book is being forwarded with original of this M/R, in compliance with Inspector Kelley's request. It is noted that the very next name on this sheet from the time book was "L. H. Oswald" underneath <sup>name</sup> of Jerry Blackburn.
