HAFIA/SCHHAFIA One of the oldent myths arcurd is that the minions of organized crime are all italians. THE GOUFATHER, J. Edgar Hoover, and the Kafauver Conduction on Crime in the early fifties all helped perpetuate this worth. Bobby Kannedy thought that the public could more easily under-stand a sinister, secret ethnic "family", complete with rituals, handbakes, and durk symbols, than they could the vast complex of the organized crime cartel that was operating behind and in front of the scenes in the US. This Notional Crime Syndicate, with bourds of directors in every major city, with no ethnic or racial boundaries, with in-vestments - if not control - in every major capitalist con-cern, and with an incon termed by its boa-, Mayer Lansky, as "hay times General Motors" (and a lot less overhead). might well pass understanding in the general public at first. But with a little effort, we can all come to com-prehend the organization behind our political and economic institutions. At least we may be able to understand the parallel between the New York Syndicate that collects the paratest between the new rows Syndicate that collects \$1million a day in heroin sales inHarlem, and the cof-fers filled by a local dope trads. By dealers every where have gotten the message; maybe some heads can too. Want to try?

HUNBLE SEGINNINGS

The mob has its roots in two distinctly ghettoized erthic groups, Italians and Jews. The Mafia, on a secret mociety, did flourish at one time. They were an honored moderty, and as much kept their fingers out of the tills society, and as much kept their fingers out of the fills of heroin and prostitution. Gamblin, vice, political excruption, excortion, and protection rackets were clean enough for them, though. In the early '20s, when Harry Analingar and the newly formed Federal Bureau of Narcotics forced heroin into a black sucker status, it was the Jewish gangaters who saw its potential for both pro-fit and social control in the black ghetto. The idea had promise, a little too much. Only the hard core dons of the Milia held out, a bitter resistance that cost them everything. On the new famous "Night of the Forty Dons" (confusedly depicted in the movie "The Godiacher"), forty Mafia heads were killed almost simultaneously. The FBI knew something was coming, since the new leadership had purchased a thousand dollars worth of flowers the day before. Too bad they didn't know what. the Marianal Grime Syndicate, vaulted the mob into Lanking, real estate brokenage, and horebry. They set up a network of city syndicates across the land, and started the foundation for an international syndicate financial cartel, extra-national getaway resorts, and the world wide heroin traffic.
