ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, AFO.

RE DALLAS TEL DECEMBER TWO, SIXTYTHREE SETTING FORTH SEVEN PENCILLED PAGES OF HANDWRITING APPARENTLY PREPARED BY OSWALD.

FOLLOWING DATA REFERS TO THOSE ITEMS IN REFERENCED TEL THAT PERTAIN TO OSWALD/S ALLEGED ACTIVITY IN NEW ORLEANS TERRITORY.

ON OCT. TWENTYSEVEN, LAST NEW YORK INFORMANT FURNISHED COPY OF UNDATED LETTER FROM OSWALD TO QUOTE MR. LEE, FPCC, SEVEN NINE NINE B/WAY, NEW YORK, NEW YORK UNQUOTE, IN WHICH OSWALD REPORTS ON HIS PROGRESS IN FORMING AN FPCC CHAPTER IN NEW ORLEANS.

NEW ORLEANS HAS NO INFORMATION RE COMMUNICATION FROM V. T. LEE TO OSWALD.

CHARLES HALL STEELE, JR. HAS BEEN IDENTIFIED AS ONE PERSON HIRED BY OSWALD TO DISTRIBUTE FPCC LITERATURE IN FRONT OF INTERNATIONAL TRADE MART ON AUG. SIXTEEN, LAST. INQUIRIES ARE BEING MADE TO IDENTIFY ANOTHER INDIVIDUAL WHO WAS ASSISTING OSWALD BUT NO IDENTIFICATION MADE TO DATE.

CHARLES HALL STEELE, JR. DID NOT DISPLAY RECEPTIVE ATTITUDE TO CUBA BECAUSE WHEN HE BECAME AWARE OF CONTENTS OF LITERATURE HE WAS GIVEN BY OSWALD TO DISTRIBUTE HE THREW IT IN A WAST RECEPTICLE AND ASKED OSWALD FOR THE TWO DOLLARS WHICH OSWALD PROMISED HIM FOR DISTRIBUTING THE LITERATURE. THE SECOND INDIVIDUAL ASSISTING OSWALD HAS NOT BEEN IDENTIFIED TO DATE.

~~CARLOS BRINGUIER~~, CUBAN STUDENT DIRECTOR, NEW ORLEANS, STATES IN EARLY AUGUST HAD PHILLIP GERACI, AGE FIFTEEN, WORKING AS VOLUNTEER SELLING DIRECTORATE BONDS FOR PURPOSE OF RAISING MONEY TO HELP CUBAN REFUGEES. STATES GERACI CAME INTO STORE WHERE BRINGUIER WORKS JUST BEFORE VISIT FROM OSWALD ON AUGUST FIVE, SIXTYTHREE AT WHICH TIME GERACI SAID HE HAD BEEN TOLD BY AN OFFICER HE COULD NOT SELL BONDS WITHOUT A PERMIT. BRINGUIER STATES WAS NOT SERVED WITH ANY PAPERS IN CONNECTION WITH SUCH BOND SALES. ALSO STATES HAD NEVER SOLD ANYTHING KNOWN AS INVASION BONDS.

NEW ORLEANS CITY ATTORNEY ALVIN J. LISKA ADVISED TOOK NO ACTION WHATSOEVER TO ENJOIN ANY GROUP OF CUBANS ACTIVE IN NEW ORLEANS AND COULD RECALL NO REQUESTS FOR RESTRAINING ACTION BY ANY SUCH GROUP. DID NOT RECALL OSWALD HAVING CONTACTED HIS OFFICE FOR ANY PURPOSE.

EXTENSIVE INVESTIGATION DISCLOSED THAT THE ONLY KNOWN ACTIVITY OF FPCC IN NEW ORLEANS WAS THAT OF OSWALD HIMSELF. NO OTHER MEMBERS, ASSOCIATES OR AFFILIATES HAVE BEEN IDENTIFIED.

COL. JOHN C. EVERS, COMMANDANT, TECHNICAL SCHOOL, KEESLER AIR FORCE BASE, BILOXI, MISS., ADVISED THAT STUDENT RECORDS OF MILITARY PERSONNEL TAKING ANY TYPE OF COURSE OR INSTRUCTION AT THIS BASE ARE RETAINED FOR A PERIOD OF ONLY THREE YEARS AND PRESENT RECORDS ARE AVAILABLE ONLY TO DECEMBER, NINETEEN SIXTY. EFFORTS ARE BEING MADE TO DETERMINE IF ANY RECORD MAY BE IN STORAGE FOR PERIOD NINETEEN FIFTYSIX THROUGH NINETEEN FIFTYNINE, WHICH WOULD REFLECT ATTENDANCE OF OSWALD AT ANY SCHOOL ON ABOVE BASE.

RECORDS OF KEESLER AFB AIR POLICE NOT AVAILABLE PRIOR TO YEAR NINETEEN SIXTYTWO.

NO RECORD OF LEE HARVEY OSWALD AT HARRISON COUNTY CREDIT BUREAU, GULFPORT, MISS., WHICH COVERS ENTIRE MISS. GULF COAST OR WITH BILOXI, MISS. PD.

CONCERNING INFORMATION THAT OSWALD RECEIVED A HIGH SCHOOL LEVEL

AT THE SAME TIME AS HIS SCHOOLING IN BILOXI, MISS., SEARCH BEING MADE OF KEESLER AFB RECRODS TO DETERMINE IF ANY POSSIBLE REFERENCE TO LEE HARVEY OSWALD IN EDUCATION DEPARTMENT.

MRS. CORA KELLY, EDUCATION SPEIALIST, EDUCATION DEPARTMENT, KEESLER AFB, ADVISED THAT IF AN INDIVIDUAL RECEIVES A GED EXAMINATION AT THE BASE, RESULTS ARE FORWARDED TO STATE DEPARTMENT OF EDUCATION IN THE STATE OF HIS RESIDENCE OR HOME OF RECORD.

NO RECORD OF LEE HARVEY OSWALD FOUND IN CONNECTION WITH DIPLOMAS ISSUED AT BILOXI HIGH SCHOOL, BILOXI, MISS.

SEPARATE TELETYPE HAS BEEN FORWARDED TO MILWAUKEE AND SAN ANTONIO FOR SEARCH OF U. S. ARMED FORCES INSTITUTE RECORDS AT MADISON, WISC. AND BOARD OF EDUCATION RECORDS AT AUSTIN, TEX.

FACTS CONCERNING THE AUG. NINE, SIXTYTHREE ARREST OF OSWALD WITH THREE CUBANS FOR DISTURBING THE PEACE WHILE DISTRIBUTING FAIR PLAY FOR CUBA COMMITTEE LITERATURE IN NEW ORLEANS AND HIS QUESTIONING BY INTELLIGENCE UNIT, NEW ORLEANS POLICE OFFICERS TOGETHER WITH FACTS REGARDING HIS PAROLE HAVE BEEN REPORTED IN FD THREE ZERO TWO/S TO DALLAS.

MUNICIPAL COURT RECORDS, NEW ORLEANS REFLECT ON AUG. TWELVE, SIXTYTHREE OSWALD APPEARED BEFORE JUDGE EDWIN A. BABYLON AND ENTERED A PLEA OF GUILTY TO THE CHARGE OF DISTURBING THE PEACE BY CREATING A SCENE AND WAS SENTENCED TO PAY A FINE OF TEN DOLLARS OR SERVE TEN DAYS IN JAIL. OSWALD PAID FINE. RECORDS SHOW PERSONS ARRESTED WITH OSWALD DISCHARGED.

ON AUGUST SIXTEEN LAST, OSWALD, STEELE AND AN UNIDENTIFIED INDIVIDUAL DISTRIBUTED FPCC LITERATURE IN FRONT OF INTERNATIONAL TRADE MART. PHOTOGRAPHS MADE BY WDSU NEW REPORTERS SHOW THAT ONLY THREE PERSONS ENGAGED IN PASSING OUT LITERATURE AND NOT FOUR AS CLAIMED BY OSWALD.

OSWALD WAS INTERVIEWED BY WILLIAM K. STUCKEY AT WDSU RADIO STUDIOS ON AUG. SEVENTEEN LAST WHICH INTERVIEW WAS RECORDED. THE MANAGEMENT OF WDSU REFUSED TO BROADCAST THE TAPED RECORDING BECAUSE OF ITS LENGTH PAREN THIRTYONE MINUTES PAREN. STUCKEY USED EXERPTS FROM THIS INTERVIEW ON HIS BROADCAST LATER THAT DATE ENTITLED LATIN LISTENING POST. TRANSCRIPT OF INTERVIEW PREVIOUSLY FORWARDED BUREAU AND DALLAS.

OSWALD APPEARED ON RADIO PROGRAM BROADCAST OVER WDSU ENTITLED CONVERSATION CARTE BLANCHE ON AUG. TWENTYONE LAST AT SIX ZERO FIVE PM. EDWARD SCANNELL BUTLER AND CARLOS HOSEA BRINGUIER APPEARED ON PROGRAM WITH HIM. TRANSCRIPT OF BROADCAST PREVIOUSLY FORWARDED TO BUREAU AND DALLAS.

A ONE MINUTE FILMED INTERVIEW MADE ON AUGUST TWENTYONE, SIXTYTHREE IMMEDIATELY AFTER OSWALD/S RADIO APPEARANCE, HAS BEEN OBTAINED FROM WDSU TV, NEW ORLEANS, AND WILL BE FORWARDED BUREAU.

JOHN I. ANDERSON, MAILERS SERVICE CO., TWO TWO FIVE MAGAZINE ST., NEW ORLEANS, ADVISED THIS DATE THAT LEE H. OSWALD CAME TO HIS PRINTING CO. ON JUNE THREE, SIXTYTHREE AND ORDERED FIVE HUNDRED COPIES OF A FOUR INCH BY NINE INCH FORM SOLICITING MEMBERSHIP IN AND/ OR CONTRIBUTIONS TO THE FAIR PLAY FOR CUBA COMMITTEE. ANDERSON STATED OSWALD RETURNED ON JUNE FIVE, SIXTYTHREE AND PICKED UP THE COMPLETED ORDER PAYING CASH. ANDERSON SAID OSWALD RETURNED SOME TIME LATER IN JUNE, JULY OR AUG., SIXTYTHREE AND ORDERED THREE HUNDRED COPIES OF A TWO AND ONE HALF BY THREE AND ONE HALF INCHES PAPER WHICH APPEARED TO BE A MEMBERSHIP CARD AND CONTAINED THE FOLLOWING, FAIR PLAY FOR CUBA COMMITTEE, NEW ORLEANS CHAPTER, WITH A SPACE FOR NAME, SIGNATURE AND CHAPTER PRESIDENT. HAND PRINTED SAMPLE FURNISHED BY OSWALD FROM WHICH LATTER ITEM PRINTED OBTAINED AND BEING FORWARDED FBI LABORATORY.

ANDERSON RECALLS OSWALD RETURNED A COUPLE OF DAYS LATER AND PICKED UP THE COMPLETED ORDER AND COMPLAINED THAT THE PAPER USED WAS NOT THICK ENOUGH AS HE HAD WANTED A CARD TYPE PAPER RATHER THAN THE HEAVY PAPER USED. ANDERSON SAID OSWALD, HOWEVER, TOOK THE ORDER AND PAID CASH. OSWALD DID NOT RETURN AGAIN TO ANDERSON/S PLACE OF BUSINESS ANDERSON COULD FIND NO RECORD OF THE ORDER FOR THE QUOTE MEMBERSHIP CARD UNQUOTE AND THEREFORE COULD NOT DETERMINE THE DATES OSWALD CAME IN TO PLACE THE ORDER OR TO PICK UP THE COMPLETED ORDER.

MYRA SILVER, SECRETARY, JONE PRINTING CO FOUR TWO TWO GIROD ST., NEW ORLEANS, FURNISHED HAND PRINTED SAMPLE OF HANDBILL COMMENCING QUOTE ~~HANDS~~ OFF CUBA UNQUOTE AND ENDING QUOTE EVERYONE WELCOME UNQUOTE. STATED PERSON GIVING NAME OF OSBORNE ORDERED ONE THOUSAND COPIES INSTANT HANDBILL MAY TWENTYNINE, SIXTYTHREE, FOR DELIVERY JUNE FOUR, SIXTYTHREE. COPIES OBTAINED LATTER DATE. NINE DOLLARS EIGHTY NINE CENTS PAID IN CASH. ORIGINAL HAND PRINTED SAMPLE OBTAINED AND BEING SUBMITTED FBI LAB.

NEITHER MYRA SILVER NOR DOUGLAS JONES, PROPRIETOR, JONE PRINTING CO. COULD IDENTIFY PHOTO OF OSWALD AS PERSON ORDERING HANDBILLS THREE ZERO TWOS BEING SUBMITTED DALLAS ON ALL ABOVE ITEMS NOT PREVIOUSLY COVERED IN PRIOR THREE ZERO TWOS.

BUREAU IMMEDIATELY ADVISE WHETHER LATIN AMERICAN CONSULS IN NEW ORLEANS SHOULD BE CANVASSED TO DETERMINE IF ANY APPROACHED BY OSWALD AS ALLEGED IN LINE TWO, PAGE TWO OF REFERENCED TELETYPE. FOR BUREAU/S INFORMATION THERE ARE APPROXIMATELY TWENTY LATIN AMERICAN CONSULATES IN NEW ORLEANS. D. J. / 1/5
