Prior to the first acheduled meetinie and prior to the one that came of I yrote you about Senter. I got Bud's and Jim's approval in advanoe. I got hay's to explore. and from you, in reespoyse to both letterra, wilence. It not only was not possible for me to go see Senter waleas ho wasuithin whelchair distance but I have no idee where he is. So after doing it all it reasing nothing when now it is so urgint.

In wy continuing legal joisting with the YMY I have gotten only part of what I asked for and will pursue the rest in court. (C.A.75-19X, filles and with a better judge.) Sut what I have is zore than enough to prove that Jinwy was framed deliberately and that within the AT there is a onse of conspirtng to dany his civil righta. As i bave already written Levi the men be put in charge of the internal investigation are those in need of being investigated. (I've offered myelif as an ascistent!)

I have really brought to pase, with Jin' f fine help oaly, an incredible legal situation in who, the fact that Jivent I are both broke and Bud 10 crazy is a very large inustration.
