There is too much of that kind of thing going on. I also ignore it.

The fourth of the Whitewash series is out. It is based on 90 pages of until-now TOP SECRET executive session transcript that, like the appended FBI and Secret Service reports relevant to was Oswald a federal agent, are printed in facsimile.

Right now it is taking more time than I can find to just mail them.

If you'd like a copy, it is \$6.25 by mail. The flyers on it have not yet been delivered by the printer.

This time AP, UPI and the Washington Post Service gave it large and coast-to-coast play with no snide cracks. Often page 1.

1) I noticed your name mentioned in N.Y. Times; you are publishing "Whitewash IV." Enclosed is schematic drawing showing the impossible pivouettes of the "magic" bullet. In 1968 when I sent this sketch to Garrison (N. Orl.) in 68 in an open letter, couple days later I received a tel. call recommending me to get out of my home which would be blown up in 2 hours. Still standing, Last Sept. 12 I sent the enclosed sketch to FBI c/o the President by certified mail asking technical explanation of the ballistics I never got an answer. I have your first paper. back book.

2) By the end of the WW2 a gestapo spy (S. E.) and his gang were apprehended in this country. He (and his brother) were members of a prominent greek shipping family. This affaire is supposed to be declassified last July.

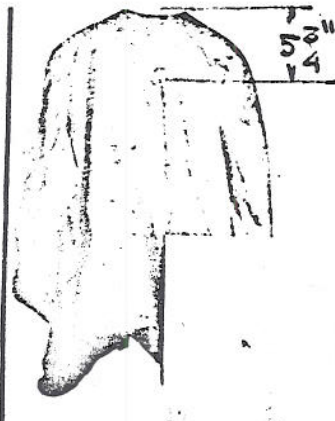
When I made a request to FBI c/o
the Attorney General, my request was
denied - I am not a registered historian.
S. E. spying for Nazi Germany has
expected a German victory and expected
a reward: a position of a Greek Quisling.
In 41 he went to Cuba to pick up a
German girl-spy and flew back to U.S.
via S. Am. Apparently it was a large
organization, could be ^{interesting} material for
a book or movie. I got off from
that gang but reported to U.S. authority.
My pay-off for a swindle by Gestapo
in 1938/39 in Europe.

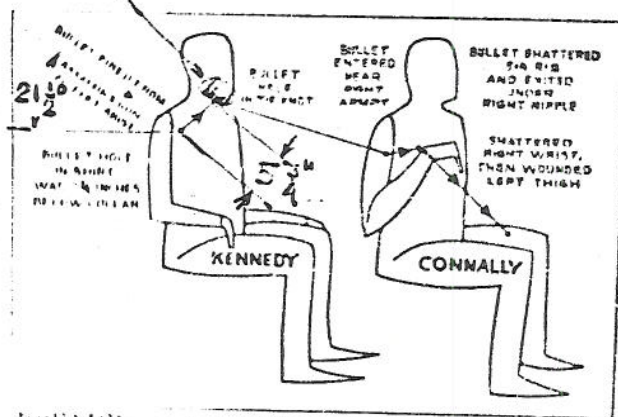
