I'm a former Wilmingtonian. Have asisted still there.

I'm also 88, feeble, and working as intensely as is now possible for me writing a series of book manuscripts to do as much as I can to perfect the record for history.

On the latent print, I'm under the impression that Day did not deliver it. My impression, and I may be wrong after all these years, is that the FBI never had that alleged print.

The actual evidence, the official and ig nored evidence, is that that Carcanno was not and could not have been used in the crime. I can't go over my records on this now because I have already turned them over to the college which will preserve them and, when arrangements like obtaining an archivist can be made, they will be publicly available.

I have also used this evidence in some of the manuscripts I've written recently but cannot recall which.

If you would care to come and go over some of these things that I can ttell you about feel free. However, I live convoluted hours, partly health and partly habit. I try to retire by six because I'm usually up by 2 a.m.

What is little known, and Hoover was part of it, is that as soon as Oswald was killed it was decided not to investigate the crime, to declare Oswald guilty and my extensive research in the Commission and the FBI's files reveals that this decision became policy and was followed. Johnson also agreed to it by phone at about 9 p.m. 11/24/63. K've the document. Hoover, for his own reasons, was strong for it.

Please excuse the haste and the brevity.
