JACK LEGN RUBY, AKA, LEE HARVEY OSWALD, AKA, VICTIM CR, OO DALLAS
RE URTEL TODAY TWELVE THIRTY EIGHT PM

KAY HELEN COLEMAN, NEE HARVEY, STAGE NAME KATHY KAY,
CURRENTLY APPEARING AT THE KINGS CLUB, OKLAHOMA CITY, OKLAHOMA
ADVISED SAS DAVID W. MC CLOSAGE AND GLENN E. SILVEY SHE BEGAN
ENGAGEMENT AT KINGS CLUB DECEMBER TWO LAST. SHE REMAINED IN
DALLAS TEXAS AT HER RESIDENCE, THREE TWO THREE N. ELING UNTIL
THAT TIME. SHE DENIED DEPARTING DALLAS HURRIEDLY AFTER RUBY
SHOT OSWALD.

COLEMAN ADVISED SHE WAS EMPLOYED AS AN EXOTIC BY JACK RUBY
APPROXIMATELY TWO AND ONE HALF YEARS AGO AND HAS WORKED FOR HIM
AT THE CAROUSEL CLUB SINCE THAT TIME WITH THE EXCEPTION OF A
BRIEF PERIOD DURING SIXTY TWO WHEN SHE WORKED AT THE COLONY
CLUB IN DALLAS.

COLEMAN ADVISED RUBY DID NOT DATE THE DANCERS AT THE CLUB
TO HER KNOWLEDGE AT THAT RUBY HAD NEVER MADE ADVANCES TO HER
AT ANY TIME. SHE DESCRIBED RUBY AS A PERSON WITH DEFINITE
OPINIONS. WHO FELT A PERSON WHO DID NOT AGREE WITH HIM WAS THEREFORE

AGAINST HIM. SHE STATED RUBY HAD NEVER DISCUSSED POLITICS OF ANY KIND WITH HER OR IN HER PRESENCE, AND ADVISED THE CLUB BUSINESS WAS APPARENTLY HIS MAIN INTEREST IN LIFE.

COLEMAN ADVISED SHE HAD NEVER SEEN OSWALD IN THE CAROUSEL CLUB AND WAS CERTAIN THERE WAS NO CONNECTION WHATSOEVER BETWEEN OSWALD AND RUBY. SHE ADVISED ON FIRST HEARING THAT RUBY SHOT OSWALD SHE FELT HE HAD DONE IT FOR THE PUBLICITY, BUT AFTER FURTHER THOUGHT, CAN SEE NO REASON RUBY MAY HAVE HAD.

COLEMAN ADVISED SHE HAS DATED HARRY OLSEN, PATROLMAN, DALLAS POLICE DEPARTMENT PRESENTLY HOSPITALIZED AT METROBIST HOSPITAL, ON A REGULAR BASIS FOR OVER A YEAR. SHE STATED THEY HAD DISCUSSED MARRIAGE BUT DUE TO HER OCCUPATION, NO PLANS HAD BEEN MADE. SHE ADVISED OLSEN'S FATHER IS A PREACHER AND THOUGH SHE HAS MET OLSEN'S FAMILY, THEY ARE NOT AWARE OF HER OCCUPATION.

COLEMAN STATED OLSEN DID NOT LIKE JACK RUBY AT ALL AND SELDOM CAME TO THE CAROUSEL CLUB. SHE STATED RUBY DISCOURAGED BOY FRIENDS OF THE DANCERS FREQUENTING THE CLUB. COLEMAN STATED OLSEN'S DISLIKE FOR RUBY STEMMED FROM HIS REFUSAL TO GRANT TIME OFF TO HER.

COLEMAN ADVISED OLSEN WAS ON DAYS OFF DURING THE WEEKEND OF THE ASSASSINATION AND THE SHOOTING OF OSWALD. FURTHER, SHE AND

OLSEN WERE TOGETHER AT THE TIME A REPLAY OF THE SHOOTING OF
OSWALD APPEARED ON THE TELEVISION AND OLSEN MADE NO COMMENT WHICH
WOULD INDICATE ANY CONNECTION BETWEEN RUBY AND MEMBERS OF THE
DALLAS POLICE DEPT. COLEMAN WAS OF THE OPINION RUBY TALKED
HIS WAY INTO THE POLICE DEPT. ON THE DAY HE SHOT OSWALD. SHE
STATED RUBY WAS FRIENDLY TO MEMBERS OF THE POLICE DEPT.

AND GENERAL ATTENDED THE CASE OCCASIONALLY.

COLEMAN ADVISED RUBY HAS MENTIONED BEING FROM CHICAGO
AND HAVING A SON WHO IS A CHILD OF YOUTH AIN, BUT HE HAS
NEVER SPECIFIC ABOUT HIS BACKGROUND OR ACTIVITIES AWAY FROM
THE CASE.
