AN OPEN LETTER TO THE HONORABLE EARL WARREN, CHIEF JUSTICE OF THE UNITED STATES SUPREME COURT AND CHAIRMAN OF THE PRESIDENT'S COMMISSION ON THE ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY

We appeal to you to produce the photographs and x-rays taken during the autopsy performed on the President's body so that we may know by the evidence of our own eyes where the wound was situated, and thus whether there might have been more than one assassin.

We, the undersigned, intend to use all resources at our command to determine what really happened in Dallas on November 22-24, 1963. We serve notice that we intend to uncover the whole truth, wherever it may lead, regardless of personal cost or risk. We appeal to all witnesses and citizens who can throw light on those events to come forward and help us in the search for the full facts.
