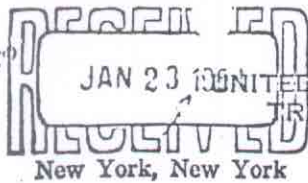

DETAILS

SYNOPSIS

File of subject obtained from Manhattan District Attorney's Office, 155 Leonard Street, New York City. Information received that subject has left the New York area and is presently in Hollywood, California.

(A) INTRODUCTION:

Reference is made to my report dated November 21, 1963.

(B) GENERAL INQUIRIES:

On January 10, 1964, Mr. Stewart Schoen called the reporting agent and informed that he had received a long distance call from the subject during which she stated that she had left the New York City area and was presently residing at the Hollywood Colonial Hotel, 730 N. Western Avenue, Hollywood, California. She added that the hotel was under the management of Mr. C. J. Powers, and the phone numbers were Hollywood 7-5141 and Hollywood 5-1195. Schoen said that subject had further stated that she had been receiving threatening phone calls at the hotel and that she had been in touch with an Agent Bayles or Bayless of our Los Angeles office.

The reporting agent obtained the file of subject from Mr. Uviller in the Manhattan District Attorney's Office, 155 Leonard Street, New York, New York. A copy is attached.

On January 20, 1964, reporting agent called Mr. Backer, Manager of the Sherman Square Hotel, Broadway at 71st Street, New York City to confirm subject's departure. Mr. Backer stated that the Kellys had departed the Sherman

Square Hotel some time during the first week of January 1964, owing back rent. He added that Mrs. Kelly had left a phone number in Palm Springs, California. The number left was 714329106. When he called that number, the woman who answered was evasive, but he believed her to be Mrs. Raye Rosensweig, 36-87 Sunny Dunes Road, Palm Springs, California, the subject's foster mother.
