Dear Mr. Whitaker:

I transmit to you herewith a confidential statement consisting of the original transcript of the testimony of Mrs. Donald Gilman taken before the President's Commission on the Assassination of President Kennedy on May 20, 1964. Mrs. Gilman is confined at the Lincoln Valley State Hospital, Kingsland, New York. This is apparently a New York State Security Council institution and because of that we have at times had difficulty regarding Mrs. Gilman.

It is necessary that Mrs. Gilman read and sign the enclosed original copy of the transcript. She may be permitted to make corrections. However, any correction she wishes to be indicated by her. She is to make the corrections and sign the transcript in the presence of the member of your staff who presents the transcript to her.

Will you please be good enough to arrange to have a member of your staff take the transcript to her in Kingsland, and have her read and execute the same as indicated above.

The Gilmans are a young couple of very limited means and this, coupled with the unenviable activities of the mental institution, will prevent her and her husband from being able to carry out reading and executing her deposition. My impression at the time I took Mrs. Gilman's testimony was that she and her husband planned in the not too distant future to leave the institution at Kingsland and to take up residence in Florida. Therefore, I suggest you contact her by telephone before undertaking a trip (if that be necessary) to Kingsland.

Inasmuch as the Commission is seeking to fund all efforts to the winning end of its investigation, we will appreciate any facilities which you can afford this matter on that being in the interest of the country's security as rapidly as the circumstances will permit.

The Commission greatly appreciates your cooperation and assistance in this matter.


On July 15, 1964, a check of the records at the Bureau of Vital Statistics in Boston and the city records at Hull, Massachusetts, concerning this woman's alleged birth date disclosed no information concerning the subject.

In the summer of 1961 this Service received information, informally, that a woman representing herself to be a member of the Kennedy family had charged merchandise at a drug store and one other unidentified store in Hyannis Port. The unpaid accounts amounted to less than \$100.00; the Hyannis Port police ascertained that the woman in question had left town; and the Kennedy family paid the bill as a "nuisance" item. The police made no formal investigation or report of the incident, and it cannot be verified that the woman was Josephine Kelley, also known as Josephine Kennedy. At no time, to the knowledge of this Service, did Josephine Kelley attempt to contact the Kennedy family at Hyannis Port in 1961.

It is the opinion of this Service that this woman is an impostor. Our interest in her arose in connection with our protective responsibilities from her attempts to contact members of President Kennedy's family. Much of the information she furnished cannot be contested because the persons referred to are deceased or their whereabouts cannot be ascertained. It is our further opinion that this woman may be attempting to use the Commission as a platform to establish or publish a relationship with the Kennedy family.

She gave no protective information during her interviews with Special Agents of this Service, and, during the interviews, made no mention of the assassination of the President, neither prior to November 22, 1963, nor the interview in Palm Springs in 1964.
