ACCUSED RFK ASSASSIN ENTERS INNOCENT PLEA

Judge Sets Nov. 1 for Sirhan Murder Trial

LOS ANGELES (AP) — To the charge that he murdered Sen. Robert F. Kennedy, Sirhan Bishara Sirhan responded Friday in a firm, clear voice: "Not guilty."

A judge set his trial for Nov. 1, just four days before the presidential election in which Kennedy had hoped to be the Democratic nominee, and close to the Nov. 12 Memphis trial date for James Earl Ray, charged with murdering Martin Luther King.

Sirhan's attorney, Russell E. Parsons, indicated that the plea of innocent does not rule out a possible plea of innocent by reason of insanity.

rie told newsmen after the hearing that brain tests for Sirhan have not been completed, and he has yet to finish studying reports of psychiatrists.

"If a man's insane at the time of trial, you can't try him," he said. "You know, people sometimes lose their minds very suddenly . . . The door is open for almost anything."

MAY MAKE MOTIONS

Parsons reserved the right to make "appropriate motions" in the case "at least 35 days before the trial."

Sirhan, 24-year-old Jordanian immigrant, was seized moments after Kennedy was shot June 5 after claiming victory in the California Democratic presidential primary election. Sirhan has been held since under maximum security.

The hearing for plea took only 22 minutes. It was conducted in a 13th-floor makeshift courtroom in the Hall of Justice. All spectators were frisked for weapons. Present were 50 press representatives and 25 others, including the defendant's mother, Mary Sirhan, and his brothers, Adel, Sharif and Saidallah.

Sirhan walked in breezily, wearing a light blue shirt and dark slacks. He sat close to Parsons-holding his hand much of the time-and intently followed each legal maneuver. He spoke
