5 October 1968. Bobby Casper conducted a private investigation on the death of his brother when he was ~~the~~ attorney-general.

I understand the main side in it was--and maybe still is-- a Mr. Hamilton, who is now in charge of California's police secret operations branch. During World War II Hamilton was a Scotland Yard inspector. Fabian was chief inspector. Hamilton was No 2, I believe, and in charge of overseas operations. He helped train officials of the refugee governments in England who were destined to take over the security positions, after victory. The Soviet grab of Poland, Czechoslovakia, etc. prevented that.

Joseph Kennedy knew those Scotland Yard officials,--Fabian, Hamilton, & Wilson. After the War he apparently helped both Hamilton and Wilson to get better-paying positions in this country (Wilson helped to reorganize the Chicago police, and is still with it).

After Pr. Kennedy was killed, Joseph K. got hold of Hamilton ~~and~~, who then helped Bobby to conduct his "parallel" investigation into the shooting of his brother. Among the people Hamilton brought to Bobby (and Teddy, who was present) is my informant, whose task was to explain that for reasons of ballistics, it was clear that Oswald could not have been the assassin, because at that distance the bullet would have crossed the head of JFK-- and would have crossed an oak twice the thickness of a man.....

My informant believes that the killing of Bobby is a warning to the Kennedy family to give up the search....

Hamilton now has access to Sirhan Sirhan and probably has already pumped him for valuable information regarding his sponsors. The informant says that Sirhan is beginning to recuperate from the massive hashish binge in the course of which he killed RFK.

If I were writing the story, I would check with medical people about the psychic phenomena ~~known~~ in an Arab ~~sobering~~ sobering up from the fumes of hashish -- how good his memory can be in regards to his actions during the intoxication period.

My informant does not want to be connected in any way with this investigation -- which he is sure is still going on--any more. He says 47 people who poked their noses into this matter, or just happened to know too much about it, have died.

Cogitating on why JFK may have been killed he mentioned the possibility that he knew too much about Russia and Khrushchev's plans to junk the Bolshevik system there. (Notice that K. was removed very soon after JFK's death). Anyway, he says that when Bobby (or ~~me~~ -- I don't remember rightly) asked him if ~~the~~ the Soviets were behind the murder, he (my informant) said that it was impossible to say for sure, because the Soviets may well come out and reveal who had done it.

He says it is a very big conspiracy ~~with~~ operating internationally. I can vouch for that and state that the conspiracy had its ~~many~~ tentacles in the Warren Commission. Do you remember what happened with the copy of La Voz de Espana I lent you? There was on the front page a dispatch from Turin about the Carcano rifle, which stated that the FBI was ~~1~~ -- that the second bullet fired at the Presidential cavalcade came from the same weapon: the story explained that the manufacturers of the weapon stated that the ~~smallest interval between two shots must be~~ the smallest interval between two shots must be more than 2.3 seconds, while the sound track of the movie of the assassination indicated that the interval between the first and the second shot at Dallas was more than 1.9 seconds. Well, they were going to borrow that paper to photostat it and would give it back to you. Not only they did not, but ~~someone~~ someone took all the available copies at the newspaper offices in San Sebastian: I had ordered the copies of the whole half year sent to me again. All the copies came in, except the one with that story. They said it was no longer available.

I am certain that one tentacle of the organization got hold of my copy in Washington and another tentacle very probably got all the copies of it in San Sebastian.
