- 42-7 McCallough, smelled gun powder (from inside bldg 200 feet away?) Saw none anywhere to west
- 48-9 abnormally shot from nearby & directly in path of door
- 51-4 Solomon Jones - shot from west - not the way what he saw - person, above waste only, in bushes - 60ft away only
 (Note - none of the sightings later attributed to him)
- 55-7 Bernard Lee - shot "came from across the street in front of Al King's room" certain - military experience
 Looking "immediately, others would have seen anyone in window"
- 58-9 only young "observed police officers coming from the area where he thought the shot may have come from," a "a large clump of bushes...." opposite "King's room. View of flesh of shot obscured by masonry post wall"
- 71 of Burnett Finley - car could have come from parking south, on parking lot
- 83 Dollwhite - compare with ghornly, then
- 87 Pth Landis looked for footprints around flop house only
- 89-90 Freeman Stone: shot came "from the parking lot located north of the Fire Department" (see)
