".....J. Edgar Hoover had a contract taken out on Martin Luther King's life through a New Orleans Mafia connection, and it was carried out at the Lorraine Motel in Memphis, Tennessee on April 4, 1968...."

The role of our government in the assassination of Martin Luther King has long been unted at in certain circles, but the ecent public appeals by the King amily for a retrial of James Earl Ray has thrusted that theory into public prominence. The bullet removed from King's body has never been decisively proven to have been fired from Ray's gun. The weapon in question is a Remington Gamemaster 30.06. Ray claims a man who he knew only as "Raoul" tossed the weapon for authorities to find as a red herring. Assassinations were unable to determine that the rifle was indeed the murder weapon. New Electron microscope technology is assumed to be able to determine what previous optical microscopes could not. A string of FBI spokesmen have long argued

against the new test clanning additional data "would not significantly enhance information previously gathered...". While this is clearly a stall tactic by the agency most likely to suffer from further scrutiny and allegation, there is a strong bipartisan push to re-open the investigation.



At 6:01 p.m., on April 4, 1968, Martin Luther King stepped out of his motel room on the way to get dinner. As he leaned over the railing of the balcony to speak to his chauffeur, a rifle shot rang out, knocking him back onto the balcony floor, where he lay dying. Five years earlier. John F. Kennedy lay in the back seat of his limo in Dallas, already dead on the way to the hospital.
