AT APPROXIMATELY TWELVE FIFTYFIVE PM APRIL ONE INSTANT [REDACTED] RESERVATIONIST, AMERICAN AIRLINES, MEMPHIS, TENN., RECEIVED A CALL FROM A MALE INDIVIDUAL WHO SPOKE IN A CLEAR, PRECISE, EMPHATIC VOICE. [REDACTED] JUDGED HIM TO BE MIDDLE AGED AND A WHITE MAN AND HEARD NO BACKGROUND NOISES. THE MAN ASKED "IS THIS THE AMERICAN AIRLINES OFFICE?" [REDACTED] REPLIED YES. THE MAN SAID "YOUR AIRLINES BROUGHT MARTIN LUTHER KING INTO MEMPHIS AND WHEN HE COMES IN AGAIN A BOMB WILL GO OFF AND HE WILL BE ASSASSINATED ." [REDACTED] SAID THE INDIVIDUAL HUNG UP IMMEDIATELY AND SHE WAS UNDER THE IMPRESSION THE CALL WAS A LOCAL CALL.

[redacted] Reservations,
American Airlines, First National Bank Building, Whitehaven,
Tennessee, advised that at approximately 12:55 P.M.,
April 1, 1968, [redacted] Reservations Clerk,
American Airlines, received a call regarding MARTIN LUTHER
KING, JR. According to [redacted] this call was from
a male individual who talked in a clear, precise, emphatic
voice. [redacted] said [redacted] thought it was a
middle age white man talking. This individual asked [redacted]
[redacted] if this was the American Airlines office. [redacted]
[redacted] replied that it was. The male individual then
said, "Your airlines brought MARTIN LUTHER KING into Memphis
and when he comes in again, a bomb will go off and he will
be assassinated." [redacted] said the individual hung
up immediately and further stated that [redacted] was
of the opinion that this was a local call. (b)(7)(c)

regarding this call or provide any additional information
which might be of value to identify the individual responsible

Investigation in this case was predicated upon information received from the reservations office, American Airlines, to the effect that a male individual, identity unknown, had called that office on 4/1/68 and threatened to bomb the plane which was to bring Dr. MARTIN LUTHER KING back to Memphis.

The above information was immediately furnished to the Bureau and to the Atlanta Office by referenced tel.

Inasmuch as all the information furnished by the unknown person making the above mentioned call was untrue, it is recommended that this case be closed.
