

## ADVOCATION FOR WIDESPREAD GRAND JURY ACTION

For every form of attack upon human rights, there will inevitably arise by nature and necessity, a means of defense. The anti-assassination machine expands the capability for mass destruction from a select few to practically anyone, and thereby represents a revolutionary precedent in human history. This machine creates a totally new dimension to all significant human relations because it can dramatically affect any relation.

Modern technology and methodology shall inevitably make many other means of massive destruction available to the average person. The question of how to apprehend this unavoidable new circumstance deserves the focal attention of everyone, everywhere, because the answer in application shall determine the fate of civilization.

In my opinion, the only way to avert misuse of the anti-assassination machine, or anything else like it, is to create a society which no one would want to destroy. Toward this objective I offer the following analysis and recommendations:

The highest, most gratifying and enduring experience is to be creative, and derive the fullest measure of direct benefit from your achievements. Whether in a physical sense such as constructing or remodeling the house you live in and own, or in a managerial sense such as determining policies and otherwise making decisions which subsequent events prove correct, and over which there is resounding approval. This inspirational experience gives one a sense of responsibility; engenders a feeling of confidence and a desire to face new challenges; and by frequent success, fosters a self-perpetuating behavioral cycle for a lifestyle adapted for upward mobility. This type of lifestyle among a broad section of people over a period of time gives them a sense of history and an awareness for national, racial and international and interracial destiny. In other words, an understanding of the past, and a confident outlook toward the future.

I believe that the first and foremost step to stimulate people to develop efficient, productive and self-sufficient lifestyles is by involvement in the grand jury system because it is an elementary and basic legal process which suffices many functions of the self-government process. The grand jury is empowered not only to investigate criminal charges, but anything under the sun as well. The grand jury can make recommendations for legislation.

A grand jury movement would effectively eliminate unemployment by providing not only a job for anyone who wanted one, but a job with a meaningful responsibility. Therefore, wages paid grand jurors should be the first issue to be investigated. The problems which plague the nation are many and varied. In the fields of education, old age, environmental destruction, consumerism, energy, and so on - each field with thousands of specific and potential problems - each of which could warrant a grand jury investigation. There are as many hair-raising problems in the area of medical drug regulation, for anyone willing to look, as there are in the more emotionally charged fields of welfare and prisons.

For instance, before a recent Senate subcommittee on health, three current and former Food and Drug Administration officials, all doctors, testified that they believed the FDA is manipulated by the drug industry.

Doctor Burton Appleton, an organic chemist for the FDA, testified that after criticizing a new drug put out by the Upjohn Company, he was removed from researching that drug and later received an employment termination notice.

Physician Marion Bryant testified that he was subjected to "years of pressure and humiliation that defies documentation," for disapproving the drug Dilatin for treating heartbeat irregularities.

Doctor John Nestor said he has been hassled since 1962 by the FDA for helping to prove that the Richardson-Merrill Company had deliberately falsified animal test data on one of their drugs. He said, "It was eventually taken off the market, but not before it had caused extensive injuries to humans."

It only takes a few examples like these to inhibit all other scientists and technicians working for the FDA, or any other regulatory agency for that matter, from doing their job honestly.

It seems that everyone with experience in Federally funded housing programs has a different story about the corruption that takes place. Contractors who spend two hundred dollars, then collect two thousand dollars for each house they renovate; grossly substandard construction materials used in new buildings; and bribery of building inspectors, are typical examples.

A common sense approach, which could very well be a grand jury recommendation, may be to de-emphasize government funding of professional contractors, and instead allocate funds for occupant renovation or to assist people to construct their own homes. This is too rarely the case in America today.

The situation with the FDA and FHA is similar, if not identical or worse in every other government regulatory agency where vast sums of money can be made by shortchanging the public. Therefore, who shouldn't the grand jury fulfill what functions regulatory agencies will not perform. What could be a more natural progressive step toward social betterment? With unemployment at the level it now is, there would certainly be no lack of manpower. Secretive investigative methods and temporary operational status excludes jurors from the influence of powerful special interests which now indirectly administer the agencies which are supposed to control them.

Since the grand jury process puts limited powers of self-government into the hands of many people, it thereby reduces the need for strong political leaders, who as history has proven, quickly become servants of private interests instead of public interests. If not, they risk assassination. This is another way of dealing with political assassination; getting along without real leaders and puppet leaders.

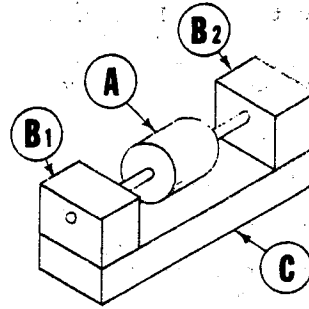
Grand jury recommendations may or may not be implemented, but they will point out common sense solutions to the problem under investigation. The grand jury system will thus serve as a steppingstone to more complex legal channels where necessary. Widespread use of the grand jury process will teach people how to take collective control over their governmental problem solving machinery as prescribed by the democratic ideal of government by the governed. Not to do so is to face the alternative of continued worsening social problems which represent, in effect, the self-devouring society destined to collapse into social chaos as has happened over and over again by civilizations throughout history.

And now a word of caution. There are many naive government officials, although most if not all have little choice but to follow the dictates of criminally corrupt politicians in charge, who think that private interests ought to have priority over the public good. They will employ every means available from their arsenal of dirty tricks to deny the public the right of self-government on all but the most inconsequential issues. They will continue to use the grand jury, as advocates for grand jury reform charge, as an instrument of oppression to harass and intimidate, and as the district attorney's rubber-stamp. They will introduce new proposals supposedly to reform but in fact to detract from the effectiveness of the grand jury process. One such scheme is to make proceedings open to the public. Public accessibility to legal proceedings is for legal processes which follow the grand jury investigation. Opponents of reform and widespread use of the grand jury represent special interests (like the drug companies), or they are opportunists and traitors; or they are very ignorant.

All I argue for is the implementation of the democratic process as the solution to whatever ails this society. I believe I have pointed out the correct direction in which to proceed toward achievement of self-government in view of the chief obstacle to representative democracy - political assassination; but not the least obstacle by far. Implementation of a grand jury movement will be determined by the ability and imagination of those who wish to see it become reality. Exactly how to proceed entails questions which can only be answered by those who are willing to take action, as only they know what they are willing and capable of doing. Their strategy should be as diverse as possible and encompass whatever means they feel are necessary to achieve uncompromising success.

## THE ANTI-ASSASSINATION MACHINE

This simple mechanism has the destructive potential of an atomic bomb. It can be completely assembled, after minor machining, from parts readily available in any hardware store. It functions by creating a vibration through the ground which can tear down an entire city in a matter of minutes, as was nearly the case with New York City, where it was first tested. The secret of successful operation is that the oscillations occur at a gradually increasing frequency. A typical design of the heart of this device (above), consists of a piece of metal (A) which oscillates between (B1) and (B2), while (C) is securely fastened to an object embedded in the ground, like the steel framework of a building. Part (C) need not be longer than twelve inches. Ideally, parts (B) and (C) should be one piece of steel. The mechanics necessary to move (A) back and forth depend on the type of energy chosen. It may be air pressure, water pressure, electricity from a battery or mechanical power. The anti-assassination application requires a reliable timing mechanism which activates the oscillator if the potential assassination victim is unable to reset it.



There are many considerations and innovations which can insure security from detection and maximize reliability of operation. For instance, location; beneath a structure which would collapse and cover the oscillator to prevent someone from stopping it. Multiple oscillators, reliable timing mechanisms, and non-corrosive parts, all help insure that it will not have to be used - as a loaded gun insures one's safety from physical attack better than an unloaded gun. Operational innovations are limited only to one's imagination and technical expertise, and have a direct bearing on the security and range of activities the builder can safely exercise in the conduct of his or her affairs.

The inevitability of massive destruction outweighs the immediate advantage of assassination. But also, the device automatically equates the protection of a person with the safety of the police themselves. Thereby, compelling them to sincerely function in their official role as law enforcement agents. This is something the police at all levels of government will not necessarily do, as evidenced by events surrounding the assassinations of President Kennedy, Robert Kennedy, Martin Luther King, Malcolm X, Mark Clark and Fred Hampton and many others.

The anti-assassination machine is an idea whose time has come. With the greatest of ease, anyone can be plucked from their worldly existence, or framed and imprisoned for the rest of their life at the instruction of any one of thousands of powerful special interests, with either the full cooperation of police administrators, or by their silent consent. This was the case with hundreds of material witnesses connected to the above political assassinations. The case of Hurricane Carter is one example out of unknown thousands. Not even the president of the United States is safe from the secret conspiracy which took over the American government at the Federal level when it murdered President Kennedy, and continues to rule by virtue of its ability to kill anyone, but also and more importantly, by its ability to control all aspects of the cover-up.

CON'TD ON BACK

The anti-assassination machine is for anyone who wishes to defend his right to live. Of course, not everyone needs one. The average truck driver does not need it. But some-one like James Hoffa, who raised the status of truck drivers above the level of garbage collectors, with a commensurate wage - a wage which otherwise would have gone to various special interests - that sort of person needs this machine. If he had it, Hoffa wouldn't have disappeared because every police agency there is would have made damn sure they knew exactly where he was every second.

Of course, the anti-assassination machine can be misused such as for blackmail. But the risk is worth protecting the quality of person who has become the leading candidate for political assassination. The only way to prevent misuse is to create a society which no one wants to destroy. The ideal society was their objective. They were killed because they were determined to create a more equitable distribution of wealth. President Kennedy said in his inaugural address; "If a free society cannot help the many who are poor, it cannot save the few who are rich." His original medicare plan would have greatly helped anyone who needed medical attention but could not afford it. After his death, the medicare proposal was altered to become "medi-ripoff."

The "anti-assassination machine" described herein is technically known as the Tesla Teleogeodynamic Oscillator, and is further described in the biography of its inventor, entitled THE PRODIGAL GENIUS, by John J. O'Neill; available from the David McKay Co., Inc., N.Y.C. However, others may find it applicable as an anti-corruption machine, an anti-war machine, an anti-environmental destruction machine, a Puerto Rican independence machine, and so forth. This device can stop oppression from modern day tyranny as no other means of defense can even approach.

How can this machine be used constructively? By making its use contingent on the safeguarding of one's human rights and the democratic process. To demand instant amnesty as the alternative to a threat to shake up the place, would be a misuse. But to demand reform of the grand jury system, then a grand jury investigation of the amnesty issue; that televised public hearings be held to fully inform and stimulate public involvement; that a referendum be held to decide the issue; this is well worth risking massive urban destruction to achieve. In this context, the phrase, "Liberty or death" has understandable meaning.

Had the facts been made known at the time, and the democratic process been allowed to run its course, who can believe there would have been a Viet Nam war? An energy crisis? A mystery to who shot President Kennedy and why? But there was no referendum on the undeclared Viet Nam war. The second vote to annul the Gulf of Tonkin resolution, after the U.S.S. Maddox incident was exposed as a hoax, came years too late for thousands of Americans. Liberty was subverted, and casualties ran into the millions while immense wealth which could have enriched the quality of life was wasted.

The idea and reality of mass destruction is nothing new, since nuclear bombs have been around for some time. Because the Tesla Oscillator avails the same destructive capability to almost anyone, its mere existence creates a totally new dimension to all significant human relations. This can not be ignored. Ethics, consideration, education and an active interest in the process of self-government are now necessities for survival. Hopefully, a new and better civilization shall be the result.
