Dear Mr Weisberg:

Thank-you for the flier on your new book. Has it gone to a printer yet?

I am just finishing up your Frame-Up book; it is really devastating & dynamite.

Although you will find some self explanatory newspaper clippings enclosed, the central purpose of this letter is to acquaint you with some valuable information you probably do not yet have. It will not be found in the Archives JFK assassination collection. I am only now passing it on to you as I had two other objectives to accomplish first.

I have shared this information with a Congressional contact who has been good enough to share not only it, but also your books with trusted friends. We have not had to contend with stiff people, being fortunate enough to put the information directly before the people running the current investigations. So, be assured that the right people are familiar with your fine work (besides a recent and superficial Dan Rather special on TV). The information I now share with you, being copied, official Government documentation, kicked the barriers to disbelief down with indisputable credibility. Just a bit later I shared this information with your friend Fensterwald, hoping to provoke him and O'Toole into finding on old YCL fix associate who of Rubenstein's - perhaps Lovestone. I was told I would be hearing from them about this. I never did and am now inclined to impute selfish motive to them. If I hadn't been so impressed with O'Toole's sleuthing and use of the Mark II Voice Analyser, I would have contacted your more democratic self. I don't like selfish people.

Although there are more pages, the essential two are enclosed. Briefly: there was a Jack Rubenstein of Chicago who was a YCL member and functionary - at the time the Jack Rubenstein was in Chicago and

was about the same age. The theory is that both Rubenstein are the same person. He subscribed to the Chicago faction (Jay Lovestone's group), was suspended, dropped out; recruited as an informer by the FBI.

I have several years of his movements in tele book listings, which may be a help sometime.

Exhibit #21 is from Congressional Hearings, HUAC, 76th Congress, 1939-40. Page number is obliterated. Exhibit #211 should be the same source, page number obliterated. In an ~~to~~ "Un-American Propaganda Activities" "Index" on p216, "Rubenstein _____" is listed on p 344, 7143 and "Rubenstein, Jack" on p593, 631; also in "Appendix I" p919 ff.

I have reason to believe that I may be able to receive, from another source, a copy of an FBI memo which links the office of Congressman Richard M Nixon to a Jack Rubenstein, there being, I believe, only a typing error involved to question. That is also a HUAC matter.

For now, that's it; it's very late.
