OFFICERS ROGER CRAIG (TESTIMONY) AND BOONE (TESTIMONY) SAW IT IMMEDIATELY AFTER ITS DISCOVERY. ALL TESTIFIED/CERTIFIED IT WAS A GERMAN MAUSER AUTOMATIC RIFLE 7.65 MM. EVEN CHIEF CURRY AND D.A. WADE STATED ON TV AND THE A.P. REPORTED IT WAS AN AUTOMATIC GERMAN MADE RIFLE. (AFFIDAVITS, TESTIMONY-MONTHS LATER!! AP REPORT - NY DAILY NEWS 11/23, TV INTERVIEW WITH POLICE CHIEF CURRY 11/22 NY TIMES 11/23 P.2)

DISTRICT ATTORNEY WADE TESTIFIED TO THE W.C.: "MY DISPLEASURE THAT CHIEF CURRY REVEALED THE DETAILS OF A FBI REPORT WHICH IDENTIFIED THE RIFLE AS A GERMAN MAUSER 7.65 MM ." THIS MEANS THAT THE FBI SAID IT WAS AN AUTOMATIC MAUSER!!!

OF ALL OF THE POLICE RADIO TRANSMISSIONS DURING THE FIRST 30 MINUTES OF THE ASSASSINATION, ONLY THREE DESCRIBE THE WEAPON. ALL THREE REFER TO A 30.06/.30 CALIBER AUTOMATIC RIFLE OR AUTOMATIC GUN BURSTS. POLICE CLAIM THE SOURCES FOR THESE DESCRIPTIONS HAVE NEVER BEEN FOUND.

AT 12:50 PM, 20 MINUTES BEFORE THE DISCOVERY OF THE RIFLE THE FIRST DESCRIPTION OF THE ASSAILANT WAS RADIOED:" UNKNOWN WHITE MALE, 30, 5'10" SLENDER, 165 POUNDS, WITH .30 CALIBER RIFLE." (CE705)

DESPITE ALL OF THE EVIDENCE TO THE CONTRARY, THE W.C. CONCLUDED THAT THE RIFLE WAS DISCOVERED BY OFFICER BOONE AND WAS A BOLT ACTION ITALIAN MANLLICHER-CACARNO 6.5 MM RIFLE.

BY THE WAY, THE ITALIAN RIFLE IS STAMPED: "MADE IN ITALY" AND "6.5MM", WHILE THE MAUSER IS STAMPED "7.65MM" ON THE BARREL! IN ADDITION, THE MAUSER DOES NOT USE A CLIP BUT A CHARGER OR "STRIPPER CLIP". THE MAUSER IS LOADED FROM THE BOTTOM AND THE STRIPPER CLIP MUST BE REMOVED BY PUSHING AN EJECT BUTTON. (SEE AFFIDAVIT). THE ITALIAN RIFLE MUST BE LOADED FROM THE TOP AND AUTOMATICALLY EJECTS THE CLIP WHEN THE LAST SHOT IS FED INTO THE CHAMBER. (NOT AFTER LAST SHOT) THE MAUSER DOES NOT HAVE A BOLT ACTION. MISIDENTIFICATION IS REMOTE AT BEST.

- 2.- THE FBI AND THE DALLAS POLICE TESTIFIED/CLAIMED THAT THEY FAILED TO PERFORM A METAL FOULING (FRESH GUNPOWDER) TEST TO DETERMINE IF THE RIFLE WAS FIRED ON 11/22/63 3H395
- 3.- AT THE HEAD FBI WASHINGTON LAB, NO FINGERPRINTS OR PALMPRINTS WERE EVER FOUND ON THE RIFLE. SEVERAL DAYS LATER, A CELLOPHANE LIFT WAS SUBMITTED TO THE FBI LAB, BY DALLAS DET. DAY, CONTAINED NO FINGERPRINTS OR LATENT PALMPRINTS EITHER!! (4H 31).

DET. DAY TESTIFIED THAT HE HAD LIFTED A PALM PRINT. HE FAILED TO GIVE THE LIFT TO THE FBI ON 11/22/63 WITH ALL OF THE OTHER EVIDENCE REGARDING THE RIFLE, AS REQUESTED BY THE FBI, SUPPOSEDLY BECAUSE HE FORGOT. DET. DAY FAILED TO PHOTOGRAPH THE PRINT BEFORE ITS PEEL. HE FAILED TO PHOTOGRAPH THE CELLOPHANE LIFT. BOTH OF WHICH ARE REQUIRED BY FBI GUIDELINES.

FOUR MONTHS LATER A PHOTOGRAPH OF THE SUPPOSED LIFT WAS SUBMITTED TO THE W.C. BY THE DALLAS POLICE. THE PROBLEM IS THAT THE PHOTOGRAPH DOES NOT SHOW CURVED EDGES AS SHOULD HAVE BEEN THE CASE WITH A LIFT OF A RIFLE BARREL.

THE W.C. CONCLUDED THAT THE ORIGINAL TEST PEELED THE ENTIRE PALMPRINT COMPLETELY OFF THE RIFLE. (EVEN THOUGH THE FBI SAID THIS IS HIGHLY UNLIKELY AND THE FACT THAT THERE IS NO PRINT ON THE LIFT!) THE W.C. BELIEVED THE TESTIMONY OF A COP, NOT THE BEST EXPERTS IN THE FIELD. IF IT WAS LHO'S RIFLE, THAN HIS FINGERPRINTS SHOULD BE ALL OVER THE RIFLE, ANYWAY? "THERE IS NO EVIDENCE OF WIPING FINGERPRINTS OFF THE RIFLE," CONCLUDE FBI EXPERT LANTANA.

ONE PROBLEM IS THAT THE ID CARD WAS NOT DISCOVERED FOR MORE THAN 48 HOURS AFTER HIS ARREST!! (IE. CHIEF CURRY TV INTERVIEW AND FBI SHANKYLFELT, NY TIMES INTERVIEW BOTH STATE: NO OTHER ALIAS OTHER THAN O.H. LEE AS OF 11/23 WHY?

TT WAS THE DUTY OF DET. DHORITY TO "MAKE COPIES OF THE DEFENDANTS (LHO) IDENTIFICATION PAPERS FOR MR. STEWART OF THE SECRET SERVICE BY 11/23/63 6:30PM. (DALLAS POLICE CASE F 85950 P.3)

THE SIGNATURE CARD FOR "A. HIDELL" AT THE DALLAS POST OFFICE IS MISSING. (IF IT EVER EXISTED) IT IS THE ONLY ONE MISSING AT THAT POST OFFICE. THE FIREARM WAS DELIVERED, WITHOUT A SIGNATURE MATCHING AN ACCURATE NAME ON THE POST BOX, AS REQUIRED BY POSTAL REGULATIONS. KLEIN'S HAS NO PROOF OF DELIVERY.

THE RIFLE LHO SUPPOSEDLY USED WAS A DIFFERENT MODEL AND LENGTH THAN LHO HAD ORDERED (ADVERTISEMENT LISTED). WHY? NO AMMUNITION CLIP OR AMMUNITION WAS SHIPPED WITH THE ORDER. IT WAS SHIPPED WITH THE SCOPE WHICH BROUGHT THE TOTAL TO \$ 19.95, (+S&H)

what represent to the differe - a regular ?

WHY WOULD LHO ORDER THE RIFLE UNDER AN ALIAS AND DELIVER IT TO A POST OFFICE BOX UNDER HIS CORRECT NAME?

KLEIN'S WAS UNDER BATF INVESTIGATION AT THE TIME OF THE ASSASSINATION. TWO BATF AGENTS AND ONE ARMY INTELLIGENCE OFFICER WERE CAUGHT IN THE TSBD 30 MINUTES AFTER THE ASSASSINATION AND MOMENTS BEFORE THE DISCOVERY OF THE RIFLE. (SEE ALIBI # 2)

THE W.C. REPORT STATES LITTLE RELIANCE CAN BE PLACED ON THIS TEST. ITS FUNNY HOW THE POLICE AND THE FBI DID. (OR TRIED TO)

13. THEN, TO REBUT THE PARAPPIN TEST RESULTS, AT THE REQUEST OF THE W.C., RADIOACTIVE TESTING OF TWO FACE CASTS OF LHO'S FACE WAS PERFORMED BY DR. VINCENT P. GUNN, HEAD OF ATOMIC DIVISION OF GENERAL DYNAMICS, DETECTED NO RESIDUE FROM GUNPOWDER/NITRITES. (WR 562) OTHER TESTS PERFORMED ON RIFLEMEN WITH OTHER SIMILAR ITALIAN CARBINES ALL PROVED POSITIVE FOR RESIDUE.

EARL WARREN KEPT THE FINDINGS OF THIS TEST SECRET (EVEN FROM THE OTHER COMMISSIONERS) UNTIL AFTER THE FINAL DRAFT WAS STARTED, STATING: "IMPOSSIBLE TO ATTACH SIGNIFICANCE TO IT." (THIS TEST METHOD) THEN WHY KEEP IT SECRET?

14.— OF THE THREE SHELL CASINGS FOUND AT THE TSBD, DALLAS POLICE ONLY TURNED OVER TWO OF THE CASINGS TO THE FBL WHY? ONE OF THOSE TWO CASINGS COULD NOT BE FIRED FROM THE RIFLE BECAUSE OF A LIP DENT. IT ALSO HAD MARKINGS THAT SHOW IT WAS FIRED FROM A WEAPON (NOT THE RIFLE!) THREE TIMES.

THE W.C. CONCLUDED THE DENT CE 543 WAS PRODUCED BY THE EJECTION FROM THE RIFLE. HOWEVER THE EJECTOR MARKS WERE NOT!!!

OF COURSE ON 6/9/64, AT THE HEIGHT OF THE INVESTIGATION, CAPT. FRITZ INFORMED THE W.C. IN WRITING THAT THE REMAINING TWO CASINGS ARE MISSING. WHY DIDN'T THE FBI REPORT THIS??

15.— THERE ARE NO CONTEMPORANEOUS NOTES, TESTIMONY OR EVIDENCE OF A CLIP WHICH WOULD BE REQUIRED TO FIRE THE RIFLE RAPIDLY. THE FIRST MENTION IS BY FBI AGENT ROBERT FRAZIER IN 6/64 TESTIMONY, THAT, NO FINGERPRINTS WERE ON THE CLIP (CE2003) HOWEVER THE ORIGINAL FBI REPORT (SEE #1) (THE ONLY ONE THAT MENTIONS THE CLIP) DESCRIBES A "FIVE SHOT CLIP WHICH WAS ISSUED FOR A MAUSER OR 30.06 (3H 398)

THE ITALIAN RIFLE USES A SIX SHOT CLIP OF WHICH THE W.C. CLAIMED CONTAINED ONLY FOUR ROUNDS. LHO KNEW HE DIDN'T NEED A FULLY LOADED CLIP!

THE W.C. STATED THE CLIP IS READILY AVAILABLE. HOWEVER, YOU COULD NOT PURCHASE IT IN DALLAS. NO INVOICE WAS EVER FOUND FOR IT? WHY?

FINALLY, THE CLIP IS AUTOMATICALLY EJECTED AFTER THE LAST ROUND HAS BEEN INJECTED INTO THE CHAMBER (NOT AFTER LAST SHOT). DID LHO PICK UP THE CLIP AND PUT IT BACK IN THE RIFLE AFTER HE KILLED JFK, BUT LEFT THE CARTRIDGES ON THE FLOOR?

ALL OF THE PHOTOS OF DET J.C. DAY WITH THE RIFLE ON 11/22/63 HAVE THE CLIP IN ITS HOUSING. HOWEVER, WHEN DAY DUSTED THE RIFLE IN THE TSBD, NO CLIP IS LISTED IN THE INVENTORY BEFORE HE LEFT THE TSBD. BURIED IN APPENDIX X THE W.C. STATES THE CLIP WAS FOUND IN THE RIFLE. THAT IS THE ONLY PLACE IT IS NOT POSSIBLE TO FIND IT, DUE TO THE FACT THAT THE CLIP WOULD HAVE BEEN AUTOMATICALLY EJECTED WHEN THE LAST CARTRIDGE ENTERED THE CHAMBER.

16. DR. GUNN AND FBI EXPERT JOHN GALLAGHER ALSO ATOMICALLY TESTED THE COMPOSITION OF THE BULLET FRAGMENTS (FROM CONNALY, LIMOUSINE AND FROM JFK) TO DETERMINE IF THEY MATCHED THE COMPOSITION OF THE MAGIC BULLET. THE W.C. REPORT QUOTES THE DR. BY STATING: "THE FRAGMENTS ARE OF SIMILAR COMPOSITION AS CE 399.

HOWEVER, ACCORDING TO SCIENTIFIC STANDARDS THIS IS ACTUALLY THE EQUIVALENT OF STATING THAT THEY ARE DIFFERENT COMPOSITION AND LOTS. (GREATER THAN 3% LESS THAN 10% DEVIATION) THEY WERE NOT MADE AT THE SAME TIME (5H67)

EVEN MORE DISTURBING IS THE FACT THAT DR. GUNN TESTIFIED TO THE W.C. THAT EACH AND EVERY FRAGMENT WEIGHED DIFFERENTLY THAN THE AUTOPSY, CONNALY AND LIMO INVENTORY REPORTS. BUT DON'T WORRY BECAUSE:

17.— ALL THE BULLET FRAGMENTS (BOTH DR. GUNN'S AND THE ORIGINAL AUTOPSY/CONNALLY/LIMO)
EXCEPT FOR THE MAGIC BULLET!, HAVE BEEN STOLEN FROM THE ARCHIVES. THE LIMOUSINE, SOME
DALLAS POLICE RECORDINGS, GUNSHOT STAINS ON CONNALLY'S CLOTHING, THE SHELL CASINGS, THE PAPER
BAG LHO SMUGGLED THE RIFLE IN, WERE MISSING EVEN BEFORE THE W.C. FISHISED INVESTIGATING. THE X
RAYS WITH "SNOWSTORM OF FRAGMENTS IN BRAIN" HAS BEEN STOLEN AND REPLACED WITH BOGUS X
RAYS AND AUTOPOSY PHOTOS. THE BRAIN HAS BEEN STOLEN WITH ITS CLOUD OF BULLET FRAGMENTS.

AT FIRST THE W.C. & OTHERS HAD THE BALLS TO SAY THE KENNEDYS HAD THE BRAIN AND LIMITED

THE AUTOPOSY WHEN IT WAS ADMIRAL BURKEY ALL THE TIME. E TU MEDIA??

ZAPRUDER FRAMES 208-212 HAVE BEEN SPLICED OFF. FBI SHANKLYFORD TESTIFIED THAT FRAME 210 WAS THE MOST CRITICAL FRAME (THE FIRST SHOT). HOW CAN THAT BE IF THE FRAME IS MISSING? EVEN COMMANDER HUMES TESTIFIED HE DESTROYED HIS BLOOD STAINED AUTOPSY NOTES AT HIS HOME IN HIS FIREPLACE ON 11/23/63. HAS ANYONE EVER HEARD OF DESTRUCTION OF EVIDENCE? 18.- THE MAGIC BULLET: FBI REPORT: CE 399 IS MISSING BETWEEN 1.5. AND 2.4 <u>GRAINS!!!</u>
MALE NURSE DARREL TOMLINSON (WHO DISCOVERED CE 399) AND SECURITY OFFICER WRIGHT (OF
PARKLAND HOSPITAL) BOTH TESTIFIED TO THE W.C. THAT C.E. 399 IS <u>NOT</u> THE SAME BULLET THEY HANDED
INTO AUTHORITIES AT PARKLAND HOSPITAL ON 11/22/63) CE 2011

BALLISTICS EXPERT JOSEPH NICHOLS TESTIFIED THAT CE 399 "CANNOT BE THE MAGIC BULLET BECAUSE IT <u>LACKS</u> BLOOD AND BONE MATTER." (3H428,429) MORE DISTURBING, HE STATES THAT CE 399 LACKS <u>ANY</u> WEAVE MARKS, WHICH WOULD HAVE BEEN MADE BY: JFK'S SPORTSCOAT, SHIRT, T SHIRT, TIE, SKIN AND CONNALY'S BACK OF COAT SHIRT, T SHIRT, FRONT OF SHIRT, FRONT OF COAT, TROUSERS AND SKIN (3H 505).

DR. DOLCE, WHO WAS CONNALY'S SURGEON IS NOWHERE TO BE FOUND IN THE WC REPORT. HE TESTIFIED TO ARLEN SPECTOR AND 5 COMMISSIONERS THAT CE 399 CANNOT BE THE MAGIC BULLET BECAUSE "IF YOU SHOOT A CADAVER'S RADIUS WRIST BONE YOU GET MORE DAMAGE THAN CE 399 POSSESSES. LHO WAS GOING TO KILL NIXON BUT I LOCKED LHO (EX MARINE) IN BATHROOM WITH NO OUTSIDE LOCK," AFTER WEEKS OF CAPITUITY BY THE SECRET SERVICE IS EVEN MORE SUSPICIOUS. FBI REPORT 11/26/63: MRS. R.E. CAROLYN ARNOLD, SECRETARY OF THE TSBD, IS NEVER MENTIONED IN THE REPORT SAW, "LHO STANDING IN THE HALLWAY BETWEEN THE FRONT DOORS AND THE DOUBLE DOORS JUST ABOUT 12:15 CD 5 P. 41 17:25 CCC650 IN 10 15:15 ON 200 Rept

25.— THE ALIBI PART 2: ROY TRULY (TSBD SUPERVISOR) AND DALLAS P.O. BAKER DECIDED SECONDS AFTER THE ASSASSINATION TO SEARCH THE TSBD ROOF. THEY ENCOUNTERED LHO ON THE SECOND FLOOR SIPPING A COKE IN FRONT OF A COKE MACHINE, LESS THAN 2 MINUTES AFTER THE ASSASSINATION.(3H241-270) HOW COULD LHO BE THERE? WHY DIDN'T THEY SEE SHELLS ON THE 6TH FLOOR AT THAT TIME? WHY DIDN'T THEY SMELL GUNPOWDER OR WHY DIDN'T ANYONE SMELL GUNPOWDER IN THE TSBD??? EVER!!

ROBERT MACNEIL (OF MACNEIL LEHRER), THEN AN NBC REPORTER, WAS IN THE MOTORCADE. HE HEARD 3 SHOTS AND <u>RUSHED</u> INTO THE TSBD TO FIND A PHONE. THE FIRST PERSON IN THE TSBD ON THE FIRST FLOOR WAS LHO, WHO DIRECTED HIM TO A PHONE. MACNEIL WAS THERE BEFORE TRULY AND

BAKER.

OFFFICER MOONEY TESTIFIED: "I WENT TOWARDS THE RAILROAD TRACKS AFTER THE SHOTS WERE FIRED BECAUSE THATS WHERE THEY CAME FROM. I WAS THEN ORDERED TO THE TSBD. WHEN I ARRIVED I TOOK THE ELEVATOR AND IT STOPPED ON THE SIXTH FLOOR. I SEARCHED VERY CAREFULLY AND FOUND NOTHING.. SO I WENT TO THE 7TH FLOOR AND FOUND NOTHING. I THEN CAME BACK TO THE 6TH FLOOR AND SAW THE 3 SHELLS IN THE MIDDLE OF THE FLOOR." (3H 283-284)

OFFICER BOONE TESTIFIED: "I HAD <u>ALREADY</u> SEARCHED THE 6TH FLOOR AND FOUND NOTHING UNTIL OFFICER MOONEY CALLED ME BACK TO THE 6TH FLOOR."

CHIEF CURRY, WHO WAS IN THE CAR IN FRONT OF JFK, TESTIFIED THO THE W.C. AND RADIO TRANSCRIPTS STATE THE FIRST THING HE SAID, "GET SOME MEN BY THE RAILROAD TRACKS." THE TSBD WAS NEVER MENTIONED BY CURRY. THE RAILROAD TRACKS ARE BEHIND THE OVERPASS/KNOLL AREA, IN FRONT OF THE JFK CAR.

SHERIFF DECKER WAS IN CURRY'S CAR ON RADIO CHANNEL 2. HIS FIRST ORDER WAS: "GET MY MEN TO CLEAR THE JAILS AND SEND EVERYONE AVAILABLE TO THE RAILROAD TRACKS AND HOLD EVERYONE UNTIL HOMICIDE AND INVESTIGATORS GET THERE."

MOTORCYCLE OFFICER HARGIS, WAS TO THE REAR OF THE DRIVER'S SIDE OF THE JFK LIMO, WAS SPLATTERED BY JFK'S BRAIN MATTER AND "WAS ALMOST KNOCKED OVER." HE IMMEDIATELY WENT TO GRASST KNOLL (IN FRONT OF THE CAR) WHERE HE CONFRONTED SOMEONE WHO HAD SECRET SERVICE IDENTIFICATION. LATER THE SECRET SERVICE CLAIMED THAT NO AGENTS WERE IN THE AREA!! IF JFK WAS SHOT FROM THE REAR, HOW COULD HARGIS HAVE BEEN IN THE LINE OF FIRE IF HE WAS BEHIND JFK?? WHY DID HE GO TO THE KNOLL?

26.— THE FIRST FOUR RADIO TRANSMISSION FROM THE TIPPET ASSASSINATION SIGHT WERE AS FOLLOWS: A CIVILIAN SPEAKING THROUGH TIPPET'S CAR RADIO, "OFFICER DOWN, SHOT BY DARK AUTOMATIC PISTOL." OFFICER GERALD HILL: "SHELLS INDICATE TIPPET KILLED BY AN AUTOMATIC PISTOL." (CE1974 p.69-77, 48-49)
OFFICER HILL TESTIFIED TO THE W.C.: "MY INTITALS THAT I PUT ON THE SHELLS IS MISSING...THESE
ARE NOT THE SHELLS, NOT THEM... IT WOULD BE IMPOSSIBLE FOR AN EXPERIENCED FIREARMS EXPERT AND
POLICEMAN THAT I AM TO MAKE A MISTAKE LIKE THIS."

FBI EXPERT CUNNINGHAM TESTIFIED THAT "THE BULLETS RECOVERED FROM THE TIPPET AUTOPSY DO NOT MATCH THE SHELLS THE W.C. NOW POSSESS." 3H474!!

THE W.C. CONCLUDED HILL AND EVERYONE ELSE WAS MISTAKEN AND THAT LHO USED TWO REMINGTON RELOADED SHELLS AND 2 SMITH & WESSON SHELLS AND USED A SMITH & WESSON .38 CALIBER (NON AUTOMATIC PISTOL) AND PURPOSELY DROPPED THE SHELLS AT THE SCENE.

KANTOR ALSO TESTIFIED THAT HE SAW RUBY AT PARKLAND HOSPITAL JUST AFTER JFK ARRIVED. (STALKING JFK OR PLANTING CE 399)

SEVERAL PHONE CALLS WERE MADE SEPERATLEY TO THE FBI AND DALLAS POLICE, THE MORNING OF LHO IMPENDING MURDER, THEY WARNED OF "THREATS TO LHO'S LIFE, HE WILL NEVER MAKE IT OUT OF JAIL... A GROUP OF 100 MEN VOTED UNAMAMOUSLY TO KILL LHO." 19 H 537-8


