Thank you for exposing Gerald Posner for the fraud he is. I'm just sorry that your book CASE OPEN hasn't enjoyed the same fanfare and hype that Posner's so undeservedly received. I really wanted to read his book and pick it apart piece by piece with actual evidence that has come to light over the years from legitimate authors and researchers such as yourself, but I didn't want to purchase his book and put any of my money in his lying hands.
