
Dear Mr. Lonergan,

If the purpose of ~~you~~<sup>you</sup> coming 6/19 it to show me "a photo of an individual" you "believe is the real Lee Harvey Oswald taken after 11/24/63" do not come. At 81 and impaired health I have no time for such mythologies. No matter how sincerely you may believe what you say, it is impossible.

What you ask that I prepare for you is also impossible because none of it has any relevance to the realities of the assassination and its investigations and I do not have any of it other than the Willis slides. They, however, are sealed and put aside with what was used to print my first book and I do not want to unseal that and I do not have easy access to it now.

I am quite serious in asking you not to come now. What you list and go into has no connection with reality at all and I do not have time for such things and will not take it.
