We appreciate your birthday card and the enclosed letter very much but I hope you can understand that if I am to continue doing my work I cannot engage in any lengthy correspondence.


I have not even thought of interviewing Dr. Cattimer. All I'd get from him is propaganda. And all he has done is try to validate the official mythology. From his own political perspective, which I indicate in Post Mortem.

Posner cribbed much and did not get caught. There is nothing that is really his in his book other than those interviews and they were for the sole purpose of circumventing the existing and officially-established fact he did not like. He got that eight-second notion from Failure Analysis.

Because the assassination itself was never officially investigated and was not intended to be there are no real leads to be followed. I do not conjecture about the facts of the assassination. I could not responsibly go any farther than I did with the Dal-Tex Building.

There can't be any explanation of where Sibert and O'Neill located the back wound that does not undermine the official mythology. So, there has ~~been~~ never been any.

Because of being under the weather, I've been forced to remain at home. - Some footage from Olm Stone's "J.F.K." (the director's cut) has been received. You are ~~at~~ work completing your book, and you certainly do not need disturbances. -

On the subject of Jack Kennedy's assassination, have you had a recent opportunity to interview Dr. Lattimer, one who disagrees with the theory that multiple shooters were utilized in Dealey Plaza?

In Case Closed, Arnold Rosen has asserted that a total of 8+ seconds had elapsed during time of shooting? This would have allowed Lee Harvey Oswald time to successfully complete tasks (adding validity to lone gunman theory). Can you comment?

During several gatherings, I have made copies of pages from Six Seconds in Dallas. Author Joshua Thompson provided excerpts from Warren Commission findings. He included the following testimony given by George Mann Hibel, Jr.:

At the moment he [Harold] was almost sitting
down I heard two reports which I thought were shots
and that appeared to be completely different in sound
than the first report and was in such rapid suc-
cession, that there seemed to be practically no
time element between them. It looked to me as if
the President was struck in the right upper part of
his head (18~~th~~ 762)

Bill Sikes, Clint Hill, and Roy Gellerman
made similar remarks. Has your opinion that a-
nother assassin was placed in Nat. Inv. Building?

I have been reviewing F.B.I. autopsy report(s) on
assassination of John Kennedy. Has there ever been
official explanation, regarding statements provided by
Francis P. O'Neill, Jr. and James W. Albert? I
am referring to descriptions of wounds to back and
neck (P. 344, Duffy and Reese work).
