Thank you for your letter of August 9, 1985, in response to my previous letter to you of August 3rd. Enclosed is my check to you for \$33.75. Please send me copies of your following books, as advertised on the flier which you sent to me:

Dear Mr. Lord:

In addition to being President of the Council on Foreign Relations, I note that the current (as of March 15, 1985) list of North American Members of The Trilateral Commission lists you as a member of that organization. Also, page 3 of the June 3, 1985, issue of The Spotlight contains an alleged "Final List of Participants" who attended the 33rd annual Bilderberg Conference held at Rye Brook, New York, on May 10, 11, and 12, 1985, and I note that you are listed as having attended this particular Bilderberg Conference. Finally, you are listed in the 1960 Catalogue of the Russell Trust Association as a member of that organization, which is also known as the Skull and Bones Society. Since you are obviously very well connected, I am writing to you for your answers to the following basic elementary questions:

(1) You have been widely quoted in certain circles as having allegedly made the following statement: "The Trilateral Commission doesn't secretly run the world. The Council on Foreign Relations does that." Is this true? Did you ever make this statement, which has been widely alleged that you made?

(2) If you actually did make the above quoted statement, and since you are also a member of the secret Skull and Bones Society, then would a more accurate statement have been to the effect that the Skull and Bones Society secretly runs the world -- or at least desires and/or tries to do so?



A History of Scroll and Key bears a copyright date of 1978. We are prohibited, therefore, from photocopying the entire work as you requested. I am, however, enclosing copies of the guides to the Henry Stimson papers and diaries which you purchased with your check for four dollars.

In response to your other requests, I am also enclosing a list of collections in Manuscripts and Archives which are available for microfilm purchase. The papers of Thomas Day Thacher, comprised of thirty-one linear feet, are described in a register of sixty-three pages. The register can be ordered for our minimum mail order charge of \$12.00. Thomas Day Thacher is listed as a correspondent in the following groups of papers: the Charles M. Dear Mr. Lifton:

I obtained your address from Mr. Jim Foley, who told me that you are currently writing a second book on the JFK Assassination and suggested that I write to you. On page 868 of the Dell paperback edition of your first book, Best Evidence, you state:

"I myself think that a sophisticated appraisal of the evidence must force one to the conclusion that there was a plot involving the executive branch of the government to remove Kennedy from office and, by fabricating the evidence..., to make his death appear a historical quirk of fate."

Approximately a year and a half ago, I began trying to research/investigate a 150 year old secret society that calls itself "The Order". (I am not referring to that highly publicized neo-Nazi group from Idaho, which also calls itself "The Order".) I am referring to the Skull and Bones Society (originating from Yale University), which is legally incorporated as the Russell Trust Association (RTA), Inc. If you've read any of Dr. Antony C. Sutton's four published books in his "Order" series to date, you know what I am referring to.

I presume you are familiar with The Spotlight and the revelations that have come out as a result of E. Howard Hunt's unsuccessful (unless he wins on appeal) libel suit against Liberty Lobby and The Spotlight. It now appears that E. Howard Hunt and the CIA were involved in at least some of the operational planning and execution of the JFK Assassination. I never believed that Oswald was the lone assassin of JFK, and I'm not about to believe that a bunch of renegade CIA agents -- acting entirely on their own -- were behind the JFK Assassination. I immediately began re-searching for possible links to Skull and Bones.

Enclosed are photocopies of my "public" file to date on Skull & Bones and related matters, along with some other items that might be of interest to you. I suggest that you begin by reading the enclosed photocopies of my (to date) unanswered letters of May 17 and June 21, 1985, to Mr. William F. Buckley, Jr. Then I suggest that you read my yesterday's letter to Mr. Scott Thompson of Campaigner Publications. After this you can read my correspondence to date with Mr. Harold Weisberg, along with my request to the CIA under the Freedom of Information Act (FOIA). After I learn from Mr. Weisberg how thoroughly he researched Hugh McDonald's book, Appointment in Dallas, I will be in a better position to decide whether I should further pursue my FOIA request to the CIA. Also, you will note that I am attempting to track down Mr. Hugh McDonald, who is evidentially still alive. If you would like to talk to me about any of this, my unlisted home telephone number for nights and weekends is (713) 686-6309. I work during regular weekdays, so don't call then.

I don't know what the contents of your next book will be, but I presume you will start exploring who could have been behind the JFK Assassination. I'm not alleging that Skull & Bones was behind the JFK Assassination, but at least three of its members were involved in the coverup: (1) McGeorge Bundy, Special Assistant for National Security Affairs, (2) the late Henry Luce, then publisher of Life Magazine, and (3) the late Senator John Sherman Cooper, a member of the Warren Commission. Then there are those astounding allegations made against William F. Buckley in that old LaRouche publication, The Buckley Family. In any event, I look forward to hearing from you.

The Project analysis of the Yale Skull and Bones secret society is currently as follows: Skull and Bones or "Bones" or "The Order" is by all accounts the most prestigious senior society at Yale. With numerous members such as Averell Harriman and Vice-President Bush, Bonesmen have been at the forefront of all the critical policies undertaken in the United States for over a Century! Sutton is particularly concerned with Bonesmen being in the forefront of the notorious Establishment efforts to build-up foreign totalitarianism, particularly in Russia, Germany, and China. Please consult Sutton for the unbelievably far-flung power held by Bonesmen. Sutton's Secret Cult of the Order is particularly interesting regarding the Masonic ritual adopted by Bones and its German-Illuminati origins. To understand Skull and Bones it is vital to understand that Brown Brothers Harriman finances this secret society as an investment in the future personnel of and, therefore, control of, the United States Government and other elite institutions that traditionally draw key personnel from Yale. (Someone needs to research who controls the other Yale societies and societies such as the Porcelain Club at Harvard.) Bones has been marvelously successful as Sutton shows.

Next, the Anglophile history of the Browns and the Harrimans must be understood. The Browns were perhaps the greatest Anglo-American Merchant Bankers of all time! Originally Belfast linen dealers, the Browns moved to Baltimore where they became the leading merchants of their time and quickly graduated to Merchant Banking and issued acceptances for other merchants. They were deeply involved in The First and Second Banks of the United States. They sent a son to Liverpool to start an English branch and later set-up in New York as well. During the financial panic of 1836 the Bank of England intervened to save Brown Shipley (English Branch) from bankruptcy by advancing almost \$2,000,000 pounds, an unheard of amount for the time. While Merchant Banks fell by the 100's Brown emerged stronger than ever from the ruins. William Brown relocated to London and was knighted and entered Parliament in 1847 and named "High Sheriff" in 1863. Brown Shipley was made a member of the "Holy of Holies" of International Finance in 1916, the Acceptance House Committee of the Bank of England. The original Harriman was a railroad stock manipulator for Kuhn Loeb, the Warburg bank and another asset of the "Crown". Thus, the Browns and Harrimans, and of course their Skull and Bones, should be viewed as instruments for the "dialectical" balance of power manipulations of the "Crown."

It should be noted that Sutton does not interpret Skull and Bones as an instrument of the "Crown", but seems drawn to the spurious, and suspiciously popular right-think view of the "Illuminati" connection as the causal link, totally ignoring the theory that Masonic-Illuminism was a British strategy to overthrow the French Monarchy, not a prime cause! Nesta Webster introduced the idea that Continental Masonry is fundamentally different from British Masonry. The fact is that Masonry is loyal to the Crown. In England, therefore, Masonry is patriotic. In France it was subversive!

In this book Quigley outlines his basic philosophy and more specifically, his neo-Spenglerian philosophy of history. An understanding of Quigley's basic philosophy is essential in interpreting Quigley's revelations regarding International Finance, the Round Table Groups, and British Imperialism. Efforts to interpret Quigley without such an understanding have lead to pathetic misunderstandings as evidenced in Cleon Skousen's The Naked Capitalist. It is now clear that the Round Table was not an essentially "Socialist" conspiracy, but a "One World" imperialist one. They worked with socialist because socialists were more amenable to "One World" than free-enterprisers.

The Foreward to this edition, written by Quigley's close friend Harry J. Hogan, provides important information vital to understanding Quigley's love-hate relationship with Neo-British Imperialism. Quigley is described as a moderate Catholic who "left the Church in the formal sense, but spiritually and intellectually never left it." Thus, Quigley (as does the Vatican), admired the "One World" ideals of the Rhodes/Milner Round Table, but hated the traditional, immoral divide and conquer tactics of the "Crown", which he called "the Cecil bloc", and its financiers. Too often we forget that the Vatican has always aspired to "Catholic" (universal) world rule over nation-states of limited sovereignty--not very different from the Round Table's ideal of "World Federation." However, as we have shown elsewhere, the Round Table was merely a "moral" front for the always diabolical "Crown". It must also be remembered that the Vatican is for Feudalism, a moderate form of socialism sometimes called Fascism, and has always been hostile to Capitalism in both its (British) monopoly form and its "free-enterprise" variety.

This book should be read by everyone interested in history regardless of ideology. It presents Quigley's controversial "organic" view of civilization and his view that a "healthy", expanding civilization must inherently be the exploitation of the many by an elite.



As of this date, I have not received any reply regarding my previous letter to you of March 26, 1985, a photocopy of which I enclose for your instant reference.

I've been doing some research into your background, and I recently came across an old out of print (I think) pamphlet published several years ago by Lyndon H. LaRouche's organization. This pamphlet is entitled The Buckley Family -- Wall Street Fabians in the Conservative Movement -- and was "Reprinted from Executive Intelligence Review" with an undated copyright by Campaigner Publications. The author of this "12,000-word expose of the Buckley family's operation" was "security specialist Scott Thompson". Executive Intelligence Review and Campaigner Publications are, of course, part of Lyndon H. LaRouche's network of organizations. I doubt if any of Lyndon LaRouche's organizations still sell this amazing pamphlet, but copies have recently been advertised at \$5.00 each from A-Albionic Consulting and Research, P.O. Box 20273, Ferndale, Michigan 48220.

Unfortunately, anything published by Lyndon LaRouche can hardly be regarded as a reliable source of information. Indeed, I scarcely know what to believe of what I read in New Solidarity these days. In any event, the following startling allegations are quoted from page 11 of this pamphlet:

"As Kennedy's popularity reached its nadir following the 1962 Cuban Missile Crisis, involvement of the U.S. in a 'limited conflict' in Vietnam, and a 'left' feint with the nuclear test ban treaty, the Buckleys' 'dirty tricks' crew was called out to rig a dummy assassination of the President with full knowledge of Attorney General Robert Kennedy and Wall Street insiders on the National Security Council. (4) Apart from the sympathy this operation was intended to win for the President, multiple U.S. intelligence sources have confirmed that the dummy hit was intended to provide cover for a new U.S. invasion of Cuba and a showdown with the Soviets at precisely the moment they were being lulled by Test Ban Treaty negotiations. Minutemen, Klan and Nazi units led by Buckleyite agents were to be unleashed for a wave of domestic assassinations which, coupled with IPS 'leftist' terrorist countermeasures, were to provide Kennedy an excuse to impose a monetarist dictatorship.

"It remains unclear to this day who intervened into the dummy assassination set-up and turned it into the real thing."

Even more astounding allegations are contained in footnote (4) on page 13: "4) Field coordination for the dummy assassination appears to have been carried out by two of William Buckley's top operatives, E. Howard Hunt, and George DeMohrenschildt. Webster may have been selected as an unknowing, enthusiastic dupe in this task. (Her brother was a specialist in Jewish studies at Oxford.) Disraeli, as an intimate of Queen Victoria and the Rothschilds, was certainly not innocent. Also, for those in the know, he let the cat out of the bag with his constant ballyhooing of the mysterious power of Secret Societies on the continent.

Another product of the Warburg Institute, Robert's Mythology of Secret Societies, shows that secret societies are not what they seem to be to either their partisans or their enemies, but are, in fact, "pre-mass media" propaganda tools. The values and themes of secret societies are publicized by the exposure given primarily by the enemies of the secret societies. Thus, Disraeli's constant invocation of the "Secret Society Spectre" in fact promoted the revolutionary philosophy he pretended to oppose by exaggerating its power!

Yates' book tends to confirm the LaRouchian thesis that the great trading and banking city of Venice, insular because of the great swamps behind it, was the progenitor of Britain as the world center of trade, banking, influence, and espionage. sian networks of which the Buckleys have become leaders. DeMohrenschildt's father headed Standard Oil's subsidiary in pre-Revolutionary Russia. He himself worked for Nelson Rockefeller, then Coordinator of Inter-American Affairs, during World War II. Later, he joined the Buckleys' Pantepec oil firm in Venezuela which was integrated into Standard Oil's massive private intelligence operations in the Caribbean. When he left Pantepec, he developed several joint ventures with Schlumberger Corp., which was represented by the Buckleys' law firm, Coudert Brothers, and which also had a record of dirty tricks involvement with the Bay of Pigs and other operations. It was DeMohrenschildt who introduced Lee Harvey Oswald to Ruth Paine, the immediate controller of both Marina and Lee Harvey Oswald at the time of the assassination, as soon as he returned from the Soviet Union. It was also DeMohrenschildt who introduced Oswald to Hunt lieutenant Guy Bannister, whose New Orleans 'Minutemen-Cuban exile' network handled Oswald's further laundering as a 'leftist' through the Fair Play for Cuba Committee, fights with well-known 'Gusanos,' etc. Other Buckleyite agents involved in the Kennedy assassination include Ken Duggan, who was murdered in prison after he broke with Buckley and sought to expose his hard core 'right-wing' agents. Duggan helped set up numerous back-up teams for the Buckleys that could be used under Minutemen or 'leftist' cover."

With regard to your further alleged involvement with Nixon Watergate burglar E. Howard Hunt, the following allegations are quoted from page 5 of the above cited pamphlet:

"In 1950-52 at least three of the Buckley children -- William F., F. Reid, and Priscilla -- followed directly in their father's tracks to receive training for the future direction of their Rockefeller satrapy as employees of the Central Intelligence Agency (CIA). Referring to William F. Buckley's recruitment, E. Howard Hunt -- one of the top Rockefeller covert action men who was involved in setting up a dummy assassination against President John F. Kennedy, and, later, was to head the Watergate dirty tricks operatives who sabotaged the Nixon Administration's break with Wall Street -- recalled: 'When I got the CIA assignment to set up a CIA station in Mexico City (actually, the CIA Latin American Division HQ--ed.), Bill was the first person I thought to bring in. He accepted immediately.' In fact, the decision was not so informal."

At the time the above cited pamphlet was published, undoubtedly most people -- myself included -- would have considered the above allegations to have been beyond the realm of any reasonable possibility/credibility. After all, at that time there was no corroborating evidence that E. Howard Hunt had any involvement with the JFK Assassination. However, the recent shocking revelations that have come out as a result of E. Howard Hunt's unsuccessful libel suit against Liberty Lobby and The Spotlight tend to put this matter in a very different perspective. From what I've been reading in The Spotlight these past several weeks, I get the distinct impression that there is now hard evidence to implicate both E. Howard Hunt and the CIA in the operational planning and execution of the JFK Assassination. I never believed that Lee Harvey Oswald was the lone assassin of President John F. On rare occasions a book is published which must forever alter the way in which we view the world around us. Within a short while, it becomes difficult to understand how we could have functioned without the knowledge gained from it. *The Anglo-American Establishment* is such a book. In it Professor Carroll Quigley presents crucial "keys" without which 20th century political, economic, and military events can never be fully understood. The reader will see that this applies to events past--present--and future.

While the notion of conspiratorial influence on world events has gained credence with both extremities of the American political spectrum, and to a degree with the general public, the more academically-oriented person has tended to downplay such influence, largely because of the lack of scholarship in the presentation and analysis of the facts by those supporting the conspiracy theories. In addition, many such supporters have made themselves easy to ignore and, in fact, have themselves always assumed that they would be ignored. Professor Quigley's work does not suffer from these defects. The evidence he presents here appears irrefutable; the analysis--brilliant. In his own words:

"It is not easy for an outsider to write the history of a secret group of this kind, but... it should be done, for this group is, as I shall show, one of the most important historical facts of the twentieth century... I suppose in the long view my attitude would not be far different from that of the (society)... but agreeing with the group on goals, I cannot agree with them on methods... In this group were persons who must command the admiration and affection of all who know of them. On the other hand, in this group were persons whose lives have been a disaster to our way of life. Unfortunately... the influence of the latter kind has been stronger... I have been told that the story I relate here would be better left untold... the last thing I should wish is that anything I write could be used by the anglophobes... but I feel the truth... once told... can be of injury to no men of good will."

Carroll Quigley (1910-1977) was a highly respected professor at the School of Foreign Service at Georgetown University. He was an instructor at Princeton and Harvard; a consultant to the U.S. Department of Defense, the House Committee on Astronautics and Space Exploration; and the U.S. Navy.

## Continued Review Empire of the City

Correction to the review of Chapter II (last issue): In the American Civil War Britain initially seemed to side with the Papal inspired Holy Alliance (including Maximilian's Mexico) and the South against the North and Russia, but failed to do anything significant to prevent the South's or Maximilian's defeat. The idea that the puny Russian fleet actually deterred British intervention is absurd! We must also question the idea that Britain was thwarted by Prussia's victory over Napoleon III's France--also part of the Holy Alliance against democracy--that had supported Maximilian in Mexico.

### Chapter III. The Eastern Question

As Carrol Quigley also notes, the decaying Turkish, Ottoman Empire (the "sick man" of Europe) was a source of conflict throughout the 19th Century and has a lot to do with the current chaos in the Middle East. Knuth notes correctly that in the early 19th Century Britain united with France and Russia to protect Christians in the then Turk-controlled Balkans and Greece from the alleged atrocities of the Moslems. Later, Britain forsook the Christians under the heel of the Turk in order to use Turkey in her balance of power manipulations against Russia. Thus, the Crimean War of 1853-56 was launched. Sardinia's House of Savoy also allied itself with Britain, France, and Turkey in the Crimean War. As part of the deal Britain put King Victor Emanuel of Savoy on the throne of a newly created "Italy" in 1861.

From here on, Knuth fails to take adequate note of the "Crown's" ancient enmity for the Vatican and the Royal Family's origins as German Princelings. Because of the conservative pretensions of the Tory Oligarchy, Knuth apparently failed to see that Britain's inner elite (including Jewish Financiers) wanted to see the ultimate failure of the Holy Alliance and loss of the Papal States to the newly formed Italy--a general victory of "liberalism" over the "old order". This was the result of the defeat of the South and Maximilian by the North in the Civil War, the defeat of Catholic France by Protestant Prussia in the Franco Prussian War, and the defeat of the Pope by Victor Emanuel in 1870. Knuth notes correctly, however, with all this going on that Russia almost slipped out of Britain's balance of power stalemate, invading Afghanistan, Turkestan, and Turkey. Only the British fleet prevented Russia from seizing control of the strategic Bosphorus and Dardanelles. With Turkey of no further use in Britain's balance of power against Russia, Britain bought Turkey's vassal government of Egypt and when "the natives" objected in armed uprisings demolished the Egyptian fleet and sent the famous "Gordon" to subdue the revolt. As is well known, Gordon was killed by the Mahdi and the Mahdi was not defeated until Lord Kitchener was sent to Egypt in 1898.

Although things were not yet "settled" for the British, and never will be for an "insular" state playing the dynamic balance of power game, this episode should not be characterized as "Britain on the run" as Knuth attempted to do. With the Catholic oriented Holy Alliance in shambles Britain had won a great victory and was in a better position to be the conductor of the "Concert of Europe".

### Chapter IV. The Concert of Europe

Knuth's probably Catholic prejudices begin to show in this chapter. The "Concert of Europe" is presented as an anti-British force for peace and justice. No mention is made of the notorious Treaty of Verona through which the Pope and the major Catholic nations of Austria, Spain, and France, with Britain's apparently fake initial compliance, had agreed to stamp-out democracy and individuals rights once and for all and to restore the "Divine Rights" of Kings!

After the Russian victories over the Turk, Knuth pictures Britain as piteously applying to the "Concert of Europe" to limit Russia's advance. But Britain was always the covert conductor of the "Concert of Europe" and it got its way that time also! By threatening to arm Austria against Russia and calling out her own reserves, Britain black-mailed the Congress of Berlin into depriving Russia of territorial gain. Britain seized Cyprus as a base against further Russian advance and Austria was given conquered Turkish provinces. Knuth then incorrectly states that the British balance of power was in abeyance and the Concert of Europe ruled independent of Britain, in peace for 43 years. What nonsense! Britain's balance of power was effected and Britain again secured her role as the "Conductor" of the "Concert" of Europe.

The correct point that Knuth could have made, but didn't is that an "insular" naval power like Britain is free to soak other nation in blood in order to maintain its own balance of power scheme. On the other hand, vulnerable "Continental" powers are more likely to come to peaceful arrangements regarding spheres of influence, etc.
