Thank you for sending me the two copies of "Whitewash," for which I trust that you have received my check in payment.

I do find that, in reading your book, I need a copy of the Committee Report in order to observe the exact reference. I have a friend who owns a copy of the report - & will borrow same - then loan her copy of "Whitewash".

In reading page 50 - 2nd. paragraph - I am astounded to note the protection taken for the Vice-Presidential cor., as opposed to the lack of it (protection) in the Presidential cor. Of course, you don't thus far give any evidence which would suggest anything in manner which would be construed as as a VP involvement, there are many who have said that they believe such an involvement exists.

This letter must not involve me any more than it should involve its recipient, which is you in case you wish to respond - in which case you could only indicate

Something which would be of an affirmative type response —  
"nothing" as I've given you nothing to which you would respond  
negatively — unless you wish to make some kind of response  
in the negative, which I would understand as meaning that  
there was nothing in your investigation to bear out the  
last question of any involvement — or suspicion of same.

Insert a few "yes's" — or a few "no's" & I'll get your  
response — no matter in what reference you use either of the  
two words.

I am deeply impressed with the study you have made —  
the vast calculations involved, and, while I've read only 50  
pages, I find the need of a copy of the Report to continue  
to make use of your references — properly & understandably.

Those men were too busy to be assigned this task — since  
it could not, for that reason, be properly undertaken. But,  
because they accepted it — it should have received more of  
their attention than was given it — at the expense of other  
or primary duties.

The easy way out was to accept the arrested person, Oswald,  
and frame the facts to support his guilt.

I recall quite vividly at the time that there was a chase up "a grassy knoll" near the viaduct - where shots were thought to have come from. And the thought that the wound in the neck was a "puncture" ironed - evidence from the front - would uphold the belief that there was an assassin toward the front.

The ~~other~~ <sup>Zapruder</sup> picture frames which were obscured by the sign & other obstructions - offer some considerable evidence that the 6th floor of the Book Bldg. was not the only source from which a bullet could have come.

It's tragic that history is written as some may wish it to be written - rather than by the facts. But, how many ~~heroes~~ <sup>hope</sup> heroes would die an inglorious death - & how many cowards glorified?!

In my opinion your book will assist <sup>in</sup> constructing a factual account of this dastardly assassination.
