Dear Mr. Weisberg,

Please allow me to introduce myself. I am a 28 year old native Baltimorean who has been studying the Kennedy assassination for two years. My ultimate goal is to complete a thorough and objective study by November 1993 and publish a book which would be a fitting analysis of the enduring mystery on the thirtieth anniversary of the shooting.

I was only two years old when President Kennedy was killed. You may be wondering what my interest in the case may be. Please allow me to explain the motivation behind my investigation. Firstly, I feel that others my age have, for the most part, abandoned the quest for the facts of the case. Apathy has rendered my generation silent. I feel I can fill at least some part of the void and "pick up the ball" for the third generation of assassination researchers.

Most importantly, I feel my research has uncovered new and previously undiscovered facts on the shooting itself. By completing the unfinished trajectory analysis, (left undone by the House Select Committee on Assassinations,) I have determined the positions and sequence of the gunfire in Dealey Plaza. To my complete surprise, I have discovered another gunman never before considered by researchers.

I am anxious to intensify my research efforts in the coming year by interviewing some of the people involved and augmenting my trajectory analysis with computerized photo enhancement. However, I have unfortunately been unable to pursue leads any further without the aid of others who have researched the case.

That is why I have written to you, Mr. Weisberg. You are perhaps the prototypical assassination researcher and certainly have the most time logged in pursuit of the truth. **I need your help.** I need to speak with you and share ideas before continuing my research.
