Iive were at the proas conferance yeaterday. Two had conse up to take me down, not wanting me to risi driving and three ware there to take mack. I. knem only one of these three weeke sac and I sought none out. If they worry aivout moxe than I think juacificd, I an grateful to the exceseen of othors whion turned them towaxd wo.

Frior to the printing of the book, in the theught that you kigith unat soxso copless
 purpona at what const to lese tran my ectual coat. This I intonded for Manbers oniy. Ae with WIIV, when it would have holped us all for kembers to have copies (and despute their not having bean given thom have made exteabive usw of it). In cill other dealiage I must be conaistont or these will bo basie for lagitimate ocmplaint. When I have time I'11 probably mend a coupze of coptos to Hembere. Savexal hava |sant people bere and bought cophes in advenoe. It thas would be mateful/ to mond them added copios. But apong "atition" mey of haw I do not dosombe this may 1 ment huve hut ane politay. If I do not some will have legtilmate bade for personal complaint.

Xou will remamberthat with Frameup I bought and gave quite a fer coidea to
Yembers. It doos not bothar me that not one thought the oopy ras from me and not ope ount me oven' a pop corow note of thanks. ${ }^{4} t$ does bothor mo that not ouk made ony une of any sind, not one had any further inquiry, gnd that limeted es my mans are this was a very poor inventaent for me.

Howevar, I an prepared to mail to my tromber you may want any coplas you zry vant and at the promised disownat. I'11 mail hay others you may wan mant for you at the rogular priow all othern are paying, if you want any. Critiols who want coples may obtain thom from or as happoned with WWIV by a varioty of onbiduen anbtarfugea. wile I' happy for you that you have no financial probleme of this kind to contend with paying for the printting of thia book alone, macie powsible by sorimping and cotng without while I mecuaulated enough to reprint two other booics about to go out of
 to kepp this in widf, if I hop, it does not oventugte, ond I have to try to prepare for the reprinting of thoee books about to 80 out of pilnt.
