## New Evidence Confirms An Elaborate Plot...

## JFK ASSASSINATION CASE TO BE **INVESTIGATORS** RE-OPENED B'

New evidence has been found which could prove that President John F. Kennedy was not assassinated by Lee Harvey Oswald, but was, instead, the victim of a master conspiracy.

The theory is substantiated by the fact that an incredible number of people who were witnesses to, or participated in any way in the events that took place that tragic day in Dallas, Texas, died under mysterious circumstances.

A recent book, "Executive Action", and a movie based on that book have also given new life to the possibility that the entire investigation into JFK's death will be re-opened, and that this time, the real truth will be told.

"In the three-year period that to insure their silence, the followed the murder of President Kennedy and Lee Harvey sin" explanation must not be Oswald, 17 witnesses interosward, 17 witnesses inter-viewed by the Dallas police, the FBI or the Warren Commission died: six by gunfire, three in motor accidents, two by suicide, one from a cut throat, one from a karate chop to the neck, three from heart attacks, and two from 'natural' causes.

Statistics requested by the London Sunday Times to compute the life expectancy of only 15 of the deceased witnesses, concluded that on Nov. 22, 1963, the odds against all 15 wit-nesses being dead by February, 1967, was one hundred thousand trillion to one: 100,000,000,000,000,000 to 1!"

In the controversial book, "Executive Action", in which authors Mark Lane and Donald Freed maintain that the Warren Commission, specially appointed by then-President Lyndon B. Johnson to investigate the assassination of President John F. Kennedy, is an insult to American intelligence.

The authors, after 10 long

vears of exhaustive research years of exhaustive research since that fateful day in Dallas when JFK was slain, firmly believe Lee Harvey Oswald did not act alone. In fact they feel that he actually may have been an innocent victim of an elaborate conspiracy engineered by a group of extremely wealthy and powerul industrialists.

The 17 witnesses, who died within three years and three months of the assassination. apparently were exterminated

questioned for fear of unbelievable complications concerning those involved.

Now, coinciding with the publication of the book and release to the movie of the same name, Lane and Freed have announced they are pushing for the real truth — no matter how messy it might get! "We wrote this novel and a

screenplay in order to give a message of hope to the American public that the decade of lies and conspiracy is coming to an end," explained Lane. "We are seeking the opening of an independent investigation into the assassination of President Kennedy.

"Our strategy includes pub-licity, teach-ins, and the estabent of continuing investigation committees on cam-puses nationwide."

According to Freed, petitions also will be circulated and sent to all members of Congress to provoke official response. In addition, a fact sheet repudiat-ing the Warren Commission's findings will be sent to Washington legislators.

Freed also announced that the first step in the national campaign will be the signing of

A coroner who studied the evidence and others who have looked more closely into the murder of JFK are convinced beyond a doubt that a lone assassin could not have been responsible for killing the President

and Freed made it clear that the and Freed made it clear that the producers and distributors of the movie "Executive Action", were not speaking for them when they stated the film is "nothing more than entertainment" and "no re-opening of the investigation is being sough!" sought.

The plan to demand an independent inquiry was first exposed to public attention at a convention at Georgetown University in Washington, Washington, D.C., this past Nov. 23 and 24. Chief organizers of the conWatergate events rather closely and see, in its complexity, how there might well have been an elaborate plot to kill President

Kennedy.

Lane and Freed offer an educated opinion that certain industrialists didn't like the direction in which JFK was taking the country. They felt he had to be assassinated - for fear that there might well have been 22 more years of Ken-nedy's occupying the White House: six more years for John. eight years for Robert and eight years for Ted in that order.

Therefore, the authors maintain an elaborate plan was set in motion in which paid killers were hired and specially trained for the assignment.

To cover up their tracks and give substance to the "one nut theory", Lee Harvey Oswald was made the scapegoat. He was handpicked well before Nov. 22 apparently believing he was getting involved with the 'fair play for Cuba' organiza-tion. (Oswald's last words before he died were: "No-No! I'm a 'patsy'!"

The authors say groundwork was laid to make it look as if Oswald was planning the assas-

sination by himself. The conspirators probably even arranged for Oswald to get a job in the Texas School Book Depository, which would put him in the right place at the right

immediately following the

announcement of the death of JFK. This would have closed the case right there, the con-spirators felt. The authors of 'Executive

Action' are firm in their belief that the fatal shots were not fired by Oswald and instead were fired by a three-man team, positioned inside the School Book Depository and at two other locations nearby.

One location was a sewer

near the railroad located directly in front. The authors claim this is the shot that, as Abraham Zabruder's movies reveal, caused the President's fatal wound.

Contributing to the growing clamor for a re-investigation of JFK's death was the announcement by Dr. Cyril Wecht, a forensic pathologist, who investigated autopsy materials and concluded that it was "physically impossible" for only one gunman to have been responsible for Kennedy's assassination. "Not any one person could have been the shooter," the Pittsburgh coroner decided. "There had to have been at least two people

shooting."

Dr. David Wrone, a history
the University of professor at the University of Wisconsin-Stevens Point, after studying details of the assassination for ten years, concluded, "it's an irrefutable fact, there for any common citizen to see.

Dr. Wrone, Dr. Wecht, and other experts are all in agreement. The Warren Commission investigation into the assassination of JFK was a "whitewash" and the whole, unvarnished truth is yet to be uncovered.
