Attached to the Cigrence Kelley 10/27/77 letter to me is a State cable #247, 

10/27/65, "Subject: Mark Lane's Forthcoming Book on the Warren Commission."

The first paragraph says the book "is scheduled for publication in England during November 1965."

Whether or not it was so scheduled it did not happen.

The (mis)information is attributed to "A confidential source within the government" of the U.S.

For a book to appear a month after announcement of its publication generally means it has already been manufactured.

If a publisher were departing from the norm and were rushing a controversial book he would not keep the publication secret. Rather would be publicise it all he could.

There are other reasons why I tend to believe this was just bad information, not that the book was scheduled for publication and the publishes backed out. Sesides, Lane's own account in Citizen's Dissent does not, to the best of my recollection, indicate that this 11/65 publication had been scheduled.

Now it happens that at that time the same bad information reached another "ritish publisher, "eslie Frewin, while he was drafting a contract for Whitewash. His was a typical reaction: the first book would cream the market and he did not contract WW. He wrate and explained it all to me. If not for this Whitewash would have appeared in England then.

I'm fascinated at the coincidence, if coincidence it is.

More so because earlier a larger British publisher, Collins, had decided to do WW but was discouraged by John Sparrow, who reportedly has long intelligence connections.

You may want to keep this "coincidence" in mind.

Bad information on Lane's book just in time to kill mine.

until July 1965 when both were changed to the same City P. O. Box. CCI's bank balance as of October 28, 1964 exceeded \$11.000

In April 1964, Lane addressed the Eighth Convention of the International Association of Democratic Lawyers (IADL) at Budapest urging the formation of an international commission to investigate the assassination. (IADL has been designated an international (Communist front organization by the HCUA and Senate Internal Security Subcommittee.) At a meeting of American expatriates (identified as Communists or Communist sympathizers) and Italian Communists later that month in Rome, Lane stated, among other things: his expenses to visit Budapest and other European cities, including Paris and London, were being paid by the "Hungarian Government"; that CCI was being financed by "leftist" elements in the U. S., including the American Civil Liberties Union; and that "an international commission of lawyers to investigate the Oswald case was to be constituted within the next month or so under the suspices of the International Association of Democratic Lawyers". During December 1964 and January 1965, he lectured in Europe under the auspices of Bertrand Russell arguing against the conclusions of the Warren Report.
