## Ray Claim 'Another Grandstand

# Lane: Young Aides L

Two aides to Andrew Young, United States ambassador to the United Nations, allegedly leaked secret FBI files and documents to key figures attempting to obtain a trial for assassin James Earl Ray, according to Mark Lane, Ray's attorney. The documents allegedly involve J. Edgar Hoover, late FBI director, in an FBI assassination plot.

Stoney Cooks, executive assistant to Ambassador Young, denied Mr. Lane's allegations.

Mr. Lane said Ambassador Young and two of his aides, Mr. Cooks and Brady Tyson, who allegedly leaked the documents, will be called to testify at a hearing to decide whether Ray should be granted a new trial.

Mr. Lane said from his home Friday night that Walter Fauntroy, chairman of the House Assassination subcommittee investigating the slaying of Civil Rights leader Dr. Martin Luther King, briefed Mr. Young and his two aides on FBI files and documents relevant to the assassination.

"After the briefing, both aides spoke with Daniel Ellsberg (who leaked the Pentagon Papers) and Rev. James Lawson. Mr. Fauntroy also gave his information to Rev. Joseph Lowery (president of the Southern Christian Leadership Conference). Rev. Lowery then gave the information to Rev. Lawson," Mr. Lane said.

Rev. Lawson was a friend of the late Dr. King's and on Oct. 13, 1978, officiated at the marriage of Ray and Knoxville woman Anna Sandhu. Rev. Lawson is a Methodist minister from Los Angeles.

Mr. Lane said Mr. Ellsberg and Rev. Lowery have both signed affidavits that prove "without a doubt" that Mr. Hoover ordered the assassination of Dr. King. Mr. Lane said Dr. King was murdered by "a squad of off-duty and former agents reporting directly to Hoover."

Ray's attorney said Rev. Lowery is prepared to testify in court and that Mr. Ellsberg's 44-page affidavit would be used.

Mr. Lane, Friday night, conferred at his home with former State Court of Criminal Appeals judge Kenneth Galbreath. Mr. Cooks said Ambassador Young has received letters "weighing on him to influence President Carter to step in" from Rev. Lawson and from Ray. But, Mr. Cooks said, Mr. Young routinely passed them on to the House Assassinations Committee.

Mr. Cooks also said Mr. Tyson and Mr. Fauntroy, who is the unelected delegate from the District of Columbia in the House of Representatives, "are good friends. Brady has been around Washington and Congress from 1968 to 1977 and he has worked in Fauntroy's campaign and given him support and worked with him politically. Yes, it is possible that Brady and Walter Fauntroy have talked about this matter, but I know nothing about it."

Mr. Young was unavailable for comment, according to Mr. Cooks. Mr. Cooks said Mr. Young was attending an American Cancer Society dinner at the Waldorf-Astoria in New York City Friday night.

A week after his original plea, Ray recanted, wanting to change his plea and receive a jury trial, something he has never been granted. "Based on the infor-

mation we have, James Earl Ray will receive a trial by jury within the next year and will be acquitted," Mr. Lane said.

Anna Sandhu Ray, who became Mrs. James Earl Ray earlier this year, told The News-Sentinel Friday that the campaign to exonerate her husband "is being helped by a man close to the President who has access to things."

mation we have, James Earl Ray will re-  
ceive a trial by jury within the next year  
and will be acquitted," Mr. Lane said.

Anna Sandhu Ray, who became Mrs.  
James Earl Ray earlier this year, told  
The News-Sentinel Friday that the cam-  
paign to exonerate her husband "is being  
helped by a man close to the President  
who has access to things."

Questioned further, Mrs. Ray said this

man "is in a Cabinet-level position."  
Asked if the man was Mr. Young, Mrs.  
Ray only laughed.

Mr. Lane confirmed Mr. Young's in-  
volvement. "He'll be upset when he  
knows it is out," Mr. Lane said. "He'll be  
nervous about it, but he (Mr. Young)  
knows everything that we are doing and  
why."

Mr. Lane said several other affidavits  
would also be released. Mr. Lane said  
"the affidavit Anna referred to does  
prove that we know who killed Martin  
Luther King and why. Yes, it does impli-  
cate the FBI."

"We know that Hoover told several  
people to kill Dr. King," Mrs. Ray said.  
"We have the documents and the memos  
from the FBI files. The man who signed  
this 44-page affidavit gained access to  
them and came forward to us. I think he  
is a very brave man," she said, referring  
to Mr. Ellsberg.

She said the files and documents  
"clearly show" that FBI men were in-  
volved in the assassination and had man-  
aged to "infiltrate" the Civil Rights lead-  
er's inner circle.

"In all the pictures of Dr. King on the  
balcony at the hotel, there is a man giv-  
ing Dr. King mouth-to-mouth  
resuscitation. We know that man was  
working for the FBI then," she said.

Mr. Lane confirmed her claim and  
identified the man as Merrill McCollough.  
"Merrill McCollough was a special agent  
working for the FBI in 1968," Mr. Lane
