## Ray's attorney promises to call name in slaying

PETROS, Tenn. —
Mark Lane, James Earl
Ray's attorney, said he
knows the name of a
person involved in killing
Dr. Martin Luther King in
1968 and will identify the
person within two weeks.
"We have discovered
evidence to show there
was a group of people
involved in the murder of
Martin Luther King Jr."
Lane said last week after
Ray's marriage to Anna

Ray's marriage to Anna Sandhu, a 32 - year - old Knoxville divorcee.

Lane, a former New York state legislator who York state legislator who recently moved his home to Memphis in hopes of winning Ray a new trial in the Dr. King case, announced his findings at a news conference at Brushy Mountain State Prison, where Ray is serving a 99 - year sentence for Dr. King's assassination.

"I believe the prime suspects in the murder of Martin Luther King were those people associated with the Federal Bureau

of Investigation in 1968," Lane told reporters. Lane has frequently charged the FBI with being in-volved in the Memphis

volved in the Memphis slaying.

Lane said the Rev.

James Lawson, who conducted the wedding ceremony, has investigated the case on his own and come up with information that "configure templeration that configure templeration that "configure templer

own and come up with information that "confirms, complements and corroborates what I have."

Lawson was a close associate of Dr. King, and was instrumental in bringing the civil rights leader to Memphis to help calm the city, which was torn by a violent garbage strike.

The Rev. Lawson, now pastor of the Holman United Methodist Church in Los Angeles, said he agreed to perform the ceremony when asked by Miss Sandhu, who first met Ray at a court hearing last summer.

Asked if he thought it ironic that he, a Dr. King associate, would perform the wedding ceremony for the man who confessed 10

the man who confessed 10 years ago that he shot King, Lawson told UPI:
"If you'll remember, Jesus Christ said on the cross, 'Father, forgive them for they know not what they do.' There's no doubt in my mind that my marrying this couple would be in the spirit of forgiveness that Martin Luther King always strived for.

"Even if James Earl Ray were the killer beyond a shadow of a doubt, and Dr. King could return to perform the marriage, he would do it," said Lawson.

"I won't have any time alone with him," Miss Sandhu, who was divorced five years ago from an Indian student, said. "I don't feel good about that at all, but there's nothing I can do about it."

Asked if she has been

about it."

Asked if she has been criticized for planning the wedding as a publicity stunt, Miss Sandhu replied:

"People who know me know I wouldn't do this unless I was sincere."
