Dear Lasse,

I should be ashamed for not realizing that is how the shade went on! Thanks for telling me.

We also have had a hot summer, after a very cold winter. With my reduced circulation I hope we do not have another severe one. The walking is too important for me not to be able to do it.

The last bad news on NEVER AGAIN! is that it is now scheduled for March. Nothing I can do about it.

Except that Kim Lesar is too busy and has no help I cannot explain AARC. He is an honest man. But he can also be negligent from being into too much.

I avoid any contact with many of that COPA bunch some because they are dishonest, some because they are nuts, and because they all theorize conspiracies without proving them and that deceives and misleads the people. Some of them really know little about the fact and for their approach fact is not relevant. But for their efforts to get records disclosed, that is fine and I agree with them. And wish them well. By and large, quite a few of them are fine people.

I have not gotten and taken time for the Inspector General's Report because I am spending all the time I can in putting as much on paper as I can.

I'd known that Garrison went to Vegas but not that he had met Roselli there.

Plausibel Benial is a deliberate fraud. The only question before the jury was whether the grossly inaccurate article was malicious, a prerequisite for a "public person" to file for libel. The rest was made up or used what is junk and not fact.

So we got some corn and will throw in there every couple of days so if the winter gets severe they'll possibly remember where they can get food.

It was nice hearing from you with the latest news in your letter from 25/6. I am not surprised that you haven't heard anything from Posner and his publisher, it shows clearly that you have done a fine job in writing CASE Open and they know for sure, that any comments from them will only make matters worse for their part, it is always difficult to silence the truth.

For the last months we have had the warmest summer for the last one hundred years here in Denmark and the most of Europe, and I noticed in your letter that the your summer also have been very warm. But we have enjoyed the fine weather, because the summer in Denmark also can be cold and rainy. For the most of july I was on vacation with my wife and one of my grandchildren in France and England, so I haven't have much time for studying and reading lately. I have received the books I ordered some time ago from The Last Hurrah Bookshop, "Oswald in New Orleans" and "Selections from Whitewash", and look forward to read them. I am sorry to hear that your book "Never Again" are been further delayed, but I hope for you that it will soon be published.

I noticed in your letter that you, like me, receive nothing new from AARC and I wonder why. Some months ago I forwarded a check to them for some material I have ordered, but even that I have have send two more letters for a reply from them, nothing have happen. But I have received a letter from a organisation with the title "Coalition on Political Assasinations", and I wonder whether AARC are been terminated and joined together with this new organisation.

In connection with your comment about the author John H. Newman and his book "JFK and Wietnam, I can tell you that I bought this book some months ago here in Copenhagen and I also think it is a fascinating book, if you ever get in contact with Mr. Newman again, you can tell him that from me.

I got interested in his book because of an article in "The New York Times" I received from AARC some time ago.

As I told you in my last letter, I have been reading The Inspector Generals Report, which is a very interesting and also frightening document. It shows very clearly how CIA without any conscience was planning assassinations. I was surprised to discover that Jim Garrison attended a meeting in Las Vegas with the gangster John Roselli. I was not aware of that Garrison knew Roselli, but that is perhaps another story. Anyway, I presume you will get a copy of this report and read it yourself.

This lead me to another matter I would like to tell you about. Normally I try to avoid most of the books there are been published about the assassination of Prsident Kennedy, because as you have told me before, and I agree with you, that most of them are not always very reliable.
