

Senator Frank Church: I was greatly shocked and disappointed by your remarks at a Pittsburgh news conference on Saturday, January 17th, supporting "criminal sanctions" against those who betray CIA secrets.

DO YOU DARE INVOKE "CRIMINAL SANCTIONS" AGAINST EXPOSURES OF TOP LEVEL GOVERNMENT CORRUPTION MOST DECENT AND HONEST CITIZENS HOLD TO BE THE HIGHEST FORM OF TRUE "PATRIOTISM" ?

By your published statement of prejudice in favor of secrecy in governmental affairs directly affecting the lives and fortunes of all of us, you have raised serious doubts in my mind that the forthcoming report on CIA activities by your Senate Select Committee will even approach the degree of honesty and integrity of content that so many of us had hoped for, based on your earlier published declarations.

WITHOUT QUESTION, THE AVAILABLE "HARD EVIDENCE" ALREADY PUBLISHED AND CIRCULATED THROUGHOUT THE NATION, PROVES BEYOND ANY REASONABLE DOUBT THAT THE CIA WAS DIRECTLY INVOLVED IN THE ASSASSINATION OF PRESIDENT JOHN F KENNEDY IN DALLAS, TEXAS, ON NOVEMBER 22, 1963, BOTH BEFORE AND AFTER THE FACT !

THE IDENTITIES OF THE ACTUAL ASSASSINS, RECRUITED AND TRAINED FROM AMONG THE EMBITTERED CUBAN EXILE COLONY IN FLORIDA, IS UNDOUBTEDLY CONTAINED IN CIA ARCHIVES OR KNOWN TO CIA OFFICIALS. In view of your late reversion to ideological support of the CIA, seemingly a trade has been made of honesty and integrity in the report your committee is preparing to release, in return for a preferred place as the "Establishment" candidate for the Presidency. I hope you will prove me mistaken, but as of now I can only anticipate betrayal by another COVER UP for the CIA and failure to deal honestly with the known "hard evidence", which can only deepen and exacerbate the internal unrest throughout the nation today, already tending more and more to open revolt and violence on a scale never before witnessed in this nation.

WHAT A SAD GREETING YOUR COMMITTEE WILL HAVE CONTRIVED FOR THE NATION'S BICENTENNIAL YEAR !

On the practical side, how will you contrive to reach the many thousands of us who have never been on CIA or FBI payrolls, but who are willing as am I, to join with and act as conduits for passing along the information you would make criminal for a select few ? Other than by CIA and FBI "Police State" methods, how will you prevent us from passing this information across international borders to our friends and acquaintances abroad ?

Along the same line, your subcommittee under Senator Schweiker seems to be spinning its wheels trying to establish an alibi for the CIA by an assinine effort to firmly tie Lee Harvey Oswald to the Kennedy assassination despite the "hard evidence" now firmly established that the ONLY BULLET STRIKING PRESIDENT KENNEDY AND WHICH COULD POSSIBLY HAVE BEEN FIRED FROM THE BOOK DEPOSITORY, WAS A DUD AND CREATED ONLY A MINOR FLESH WOUND IN KENNEDY'S BACK.
