Dear Mr Weisberg: I have been watching the unfolding of the published activities of the Presidential and Congressional committees organized to investigate the nation's espionage apparatus. I have been wondering as I sit here contemplating and studying the picture of Mr David Belin which appeared in our local newspaper (The Arizona Republic, 1/12/75, pge A-14, Associated Press credit) and compare it with Mr Belin's most recent statement regarding the Kennedy assassination in an interview published locally in the same newspaper (The Arizona Republic, 3/1/75, pge A-27, United Press International credit), if an important facet of the personal character of this former counsel

for the Warren Commission has not been overlooked.

In the latter interview Mr Belin is reported as stating to reach the conclusion that Oswald alone Killed Kennedy, one has to work backward from the murder of Officer J D Tippit after

the assassination."

Since, according to at least one on-the-spot investigator whose book I no longer have in my library, the murder of Officer Tippit was linked to Oswald only by the Dallas Police Department on undisclosed testimony that was strongly and directly contradicted by several eyewitnesses closest to the scene of the incident, the evidential basis for the police accusation was highly doubtful. Perhaps you have later and better information on this? this ?

It reasonably appears from his own statement that Mr Belin "investigates" by first accepting a doubtful conclusion, then works backward to find evidence which supports his initial conclusion, disregarding bits of real evidence along the way which he cannot reconcile to the conclusion he seeks to establish.

I am under the impression this is the manner in which many of our best mystery novels are written, such as the Perry Mason series, but is hardly the method by which murder investigations should be conducted.

I am further wondering as I sit here, if Mr David Belin with his "weak" face (if the local newspaper portrait is a reasonable facsimile) has not inadvertently revealed himself as an extreme schizophrenic of long standing, i.e., a victim of that egoistic mental condition (not insanity) in which the person afflicted lives perpetually only half in the real world of which he is part, and the other half withdrawn into a dream world of his own making where everything he wants to be true is ipso facto the truth.

To such an egoistic and sometimes brilliant mind, imbued with the pleasant infallibility of his own dream world, the manufacture of forged "evidence" to fit his own conclusions would only be another step to arriving at TRUTH, and he would remain incapable of understanding or accepting any reasoning or valid evidence pointing to a different conclusion. He would tend instead to become violently angered by any suggestion that his conclusion could possibly be wrong.

Such schizophrenics are frequently capable of arguing bril-Such schizophrenics are frequently capable of arguing brilliantly and convincingly for their train of thought to fill in gaps of tangible evidence, and in the legal profession this could well be a valuable trait. Even the most brilliant criminal lawyers, when faced by evidence contrary to their client's interests, could (and perhaps are) a bit schizophrenic at times!

Although not a psychiatrist, I have had a close family relationship to a similar but more innocent situation and have followed the advice of a pre-eminent team of medically-trained psychiatrists in another large city, who accurately predicted the

"There is no hard evidence that has come to my atten-tion that in any way diminishes the veracity of the conclusion that Lee Harvey Oswald was the assassin and the sole assassin of President Kennedy," Belin said.

Belin leads the staff of 20 on the commission headed by rice rresident Nelson Rocke-feller. The panel was ap-pointed by President Ford to investigate charges of illegal denestic spying by the CIA. Vice President Nelson Rocke-

Comedian and political activist Dick Gregory met with the commission early this month to present what he called new evidence that there were multiple assassins and that the CIA was involved in Kennedy's death.

.Gregory based his contention largely on a copy of an amateur movie taken during the shooting of Kennedy. He . said the film proves Kennedy was shot from in front, not from the back by Oswald as concluded by the Warren commission.

"We (the Warren commission) had the original of that film, and it was clearer than Gregory's copy," Belin said. "We made 35 mm slides of

- David every frame of the movie, irrector of and I'm afraid I don't agree with his conclusions."

Belin did criticize the Warren commission for not hav-ing obtained the Xrays from Kennedy's autopsy and for not releasing the autopsy re-

"This was the major fault and it would clear up so much of this confusion if it mere done." he said. "I wrote sen. Edward Kennedy in 1973, saying enough time had passed and the Xrays should be released, but I never heard back.

"One of the main problems "One of the main problems we had (on the Warran commission) was that we had information a mile wide and an inch deep," he said. investigate the Central Intelligence Agency.

As the commission geared up to open its investigation Monday, the sources said Ford had selected David Belim, a 46-year-old Iowa lawyer who was counsel to the 1964 inquiry into the assassination of President John F. Kennedy.

Meanwhile, an FBI spokesman said Saturday night that FBI Director Clarence M. Kelley is concerned that official probing into alleged illegal domestic surveillance by the CIA may go too far a n d jeopardize the spy agency.

The spokesman said Kelley has "expressed some apprehension that perhaps the inquiry and disclosure about the Central Intelligence Agency would go too far and do harm."

Kelley believes that the commission appointed by Ford "should find out what their (the CIA's) mission is and whether they are fulfilling it, but not go into how they do what filey do," the FBI official said.

In another development, the Los Angeles Times reported that CIA Director William E. Colby has told the Justice Department he does not believe sufficient grounds exist for criminal prosecution of CIA officials or personnel involved in the alleged domestic operations.

The newspaper quoted Colby as telling Justice that initial press accounts had "exaggerated the extent of the transgressions" by linking individual wrongdoings inside the United States to extensive CIA files that reportedly contain the names of some 10,000 American citizens.

Sources said Belin would head a staff of investigators, lawyers and others aiding the commission in its probe. The commission is headed by Vice President Nelson A. Rockefeller.

Asked about Belin, White House Press Secretary Ron Nessen said he had no announcement to make.

Along with Colby, the CIA commission is expected to call as witnesses Secretary of State Henry A. Kissinger, Defense Secretary James R. Schlesinger and former CIA Director Richard Helms, now

ambassador to Iran. Schlesinger also served briefly as CIA director in 1973 before being named to the defense post.

"The staff has got to start Monday with procedural matters like what to do about subpoena powers and per diem," one administration source said. The commission presently does not have the power to issue subpoenas.

The commission is expected to set up offices in the new Executive Office Building at Pennsylvania Avenue and 17th Street, not far from the White House. The location reportedly was recommended by White House Chief of Staff Donald Rumsfeld.

The administration sources said Belin, senior partner since 1966 in the Des Moines, Iowa, law firm of Herrick, Langdon, Belin and Harris, was suggested by the President's staff recruiters, but that Rockefeller had interviewed him and agreed to the appointment.

"There's no friction on it.

The vice president agreed.

The President is not going to stuff it down the vice president's throat," the source said.

Belin, who was chairman of Lawyers for Nixon-Agnew in the 1968 presidential campaign, reportedly will head a staff of about 15, including seven investigators, a legal counsel, a congressional liaison representative, a staff administrator and a press spokesman.

Meanwhile, The London Times has published an article by a Londoner who identifies himself as a former CIA agent and suggests that that the agency spies on as many as 100 million Americans.

In a related investigation, Sen. John C. Stennis, D-Miss., said the Armed Services Committee would begin its probe of the CIA on Thursday with testimony from CIA Director Colby.

Stemis said Colby would be followed by former director Helms. The hearing would be open "to the extent possible," the senator said. But he added that "much information" would be considered in closed sessions.

Another CIA investigation is being conducted by a House special subcommittee on intelligence, headed by Lucien N. Nedzi, D-Mich.
