Dear M_T Bishop: Two matters of "hard evidence" of which you and other supporters of the Warren Report on the assassination of President John F Kennedy on November 22, 1963 seem unaware, give the LIE to the conclusions of your column in the Arizona Republic yesterday. In extenuation it appears questionable if this "hard evidence" was ever reported to and considered by the Commissioners as a body before the Report was released. Available minutes of their meetings indicate no substantive discussion of the "hard evidence" contrary to their conclusions and seemingly known to the investigative staff, to which Mr Allen Dulles of CIA descent gave much of his personal attention (See "Inquest" by Edward Jay Epstein. "The Warren Commission and the establishment of truth". Publ Viking Press - 1966. #66-021197 C.L. Index 973.922 E.)

Fact 1: The only bullet to strike President Kennedy from the rear which might have been fired from the Book Depository, created only a minor flesh wound about the middle of his back, several inches below the point indicated on the FORGED DIAGRAM of the Warren Report! Without support of this FORGED EVIDENCE the "Oswald Theory" of the Warren Report on the Kennedy assassination falls apart of its own weight.

The original surgeon's sketch prepared in the autopsy room gave the correct location of the wound in the back substantially lower than the FORGED DIAGRAM of the Warren Report, but apparently the Commissioners as a body never saw the surgeon's sketch - only the FORGERY prepared by the Commission's staff! The bullet hole in the back of Kennedy's shirt was the clue which led to rediscovery of the autopsy surgeon's original sketch and the two pieces of "hard evidence" confirmed each other. But there is more!

The only bullet striking President Kennedy which might have come from the Book Depository, NEVER PASSED THROUGH KENNEDY'S BODY BUT INFLICTED ONLY A SUPERFICIAL FLESH WOUND AN INCH OR SO IN DEPTH! The shallow depth of penetration was confirmed by the surgeon's probe, but the bullet was no longer in the wound. It was found shortly after on the floor intact where the Kennedy stretcher had temporarily stood while the autopsy room was being prepared.

If fired from an upper floor of the Book Depository as alleged, the bullet's force was largely spent and it was on a downward trajectory when it penetrated Kennedy's back to inflict a superficial flesh wound, indicate the use of low-powered or deteriorated ammunition. Such ammunition could not possibly have reversed its downward trajectory, jump upward through the rib cage to shatter bones and emerged from Kennedy's throat (which bones had miraculously healed by time the autopsy was performed), go on to wound others sitting in the car, then return unmarred to lie quietly on the hospital floor until search was made and the bullet recovered. THAT IS THE MIRACLE YOU MUST ACCEPT IF YOU STILL BELIEVE THE "OSWALD THEORY" OF THE WARREN REPORT !!!

The abrasion on the front of Kennedy's neck which the investigative staff promoted into an "exit wound", had no depth and would not permit entry of the surgeon's probe. Presumably it was no more than a small abrasion from shell fragments penetrating from the front.

BUT in order to fill the order for a "fall guy" to support your "lone assassin" theory, someone with influence in investigative capacity - presumably Allen Dulles of CIA ancestry - concocted the FORGED DIAGRAM of the Report to show the back wound as the "entry

reacting sharply to his left and rear at the moment the lethal bullet struck from the front, CLEAR AND IRREFUTABLE PROOF THAT THE LETHAL BULLET WAS FIRED FROM THE FRONT AND RIGHT OF KENNEDY'S POSITION. This was covered up in the Warren Report by use of slides of individual frames prepared from the original film by the investigative staff (See statement by David Belin in UP dispatch, Arizona Republic, 3/1/75, pge A-27). Transposed slides furnished the slight forward movement of Kennedy's head to provide false indication of a shot from the rear to support the Oswald Theory. The source of the lethal bullet as from the right and front of Kennedy's position is confirmed by your own statement of "Five and a quarter inches of skull and hair flew up from the car and backward" - IN DEFIANCE OF THE LAW OF GRAVITY IF INDEED THE SHOT WAS FROM THE REAR!

Simultaneous with the lethal bullet, a slight puff of smoke and subdued sound of a rifle shot (such as from a silencer) was reported by many persons watching the parade from points in the vicinity of a grove of trees on a nearby hillock and in the direction from which the lethal shot must have come.

The foregoing does not by any means exhaust the "hard evidence" against the conclusions of the Warren Report which you endorse. But of course your own mind is already bolted and barred against any cuestioning of your own superficial investigation as you "crouched in the School Book Depository" in Dallas a year or more after the assassination. It is clear you have never read and studied the "hard evidence" which challenges the foundations of the Warren Report. A reporter with such a pre-conditioned mind as yours, had best keep his mouth shut.

Your Dr John K Lattimer, despite his degrees, has no standing as a forensic surgeon, and no forensic surgeon of good repute and whose opinion would carry weight, has yet been permitted to examine the materials upon which Dr Lattimer based his unsupported opinions.

I shall, of course, send a copy of this letter to your Dr Lattimer as you suggest and, if he cares to make a significant reply, I shall pass it on to others who, like myself, consider the entire Warren Commission investigation a DELIBERATE FRAUD upon the American people, perpetrated as a POLITICAL COVER-UP OF THE PLANNED ASSASSINATION OF AN ELECTED PRESIDENT OF THE UNITED STATES, by a person or persons with CIA connections (Allen Dulles?) and with sufficient influence to control the extent of the evidence the other members of that Commission were permitted to examine and consider, and capable of additionally FORGING EVIDENCE to support theories not justified by the available facts.

Dear Mr Weisberg: I have been watching the unfolding of the published activities of the Presidential and Congressional committees organized to investigate the nation's espionage apparatus. I have been wondering as I sit here contemplating and studying the picture of Mr David Belin which appeared in our local newspaper (The Arizona Republic, 1/12/75, pge A-14, Associated Press credit) and compare it with Mr Belin's most recent statement regarding the Kennedy assassination in an interview published locally in the same newspaper (The Arizona Republic, 3/1/75, pge A-27, United Press International credit), if an important facet of the personal character of this former counsel for the Warren Commission has not been overlooked.

In the latter interview Mr Belin is reported as stating
"to reach the conclusion that Oswald alone Killed Kennedy, one has to work backward from the murder of Officer J D Tippit after

the assassination."

Since, according to at least one on-the-spot investigator whose book I no longer have in my library, the murder of Officer Tippit was linked to Oswald only by the Dallas Police Department on undisclosed testimony that was strongly and directly contradicted by several eyewitnesses closest to the scene of the incident, the evidential basis for the police accusation was highly doubtful. Perhaps you have later and better information on this?

It reasonably appears from his own statement that Mr Belin "investigates" by first accepting a doubtful conclusion, then works backward to find evidence which supports his initial conclusion, disregarding bits of real evidence along the way which he cannot reconcile to the conclusion he seeks to establish.

I am under the impression this is the manner in which many of our best mystery novels are written, such as the Perry Mason series, but is hardly the method by which murder investigations

should be conducted.

I am further wondering as I sit here, if Mr David Belin with his "weak" face (if the local newspaper portrait is a reasonable facsimile) has not inadvertently revealed himself as an extreme schizophrenic of long standing, i.e., a victim of that egoistic mental condition (not insanity) in which the person afflicted lives perpetually only half in the real world of which he is part, and the other half withdrawn into a dream world of his own making where everything he wants to be true is ipso facto the truth.

To such an egoistic and sometimes brilliant mind, imbued with the pleasant infallibility of his own dream world, the manufacture of forged "evidence" to fit his own conclusions would only be another step to arriving at TRUTH, and he would remain incapable of understanding or accepting any reasoning or valid evidence pointing to a different conclusion. He would tend instead to become violently angered by any suggestion that his conclusion could possibly be wrong.

Such schizophrenics are frequently capable of arguing brilliantly and convincingly for their train of thought to fill in gaps of tangible evidence, and in the legal profession this could well be a valuable trait.
