In view of the fact that Ray allegedly contacted a contracting or architectural firm, and in view of the information concerning a fence by the name of [REDACTED] the possibility exists that the fence may be a [REDACTED] or [REDACTED]. New Orleans is being granted permission to obtain Federal Grand Jury subpoena for pertinent telephone records regarding the [REDACTED] and individuals listed under name of [REDACTED] in the New Orleans area.
