FOUR QUERIED

Strate, Gervais, Baldwin. Sheridan Appear

Four persons appeared before the federal grand jury Tuesday in its investigation into an alleged conspiracy aimed at freeing Teamster Union President James R. Hoffa who is serving an eight-year term for jury tampering.

Those who appeared before the jury included Zachary A. "Red" Strate, New Orleans contractor; Walter Sheridan, newsman for the National Broadcasting Company; Edward M. Baldwin, a New Orleans attorney; and Pershing Gervais, former chief investigator for District Attorney Jim Garrison.

The grand jury recessed shortly after noon and is scheduled to go back into the probe at 9:30 a.m., Wednesday.

United States Attorney Louis C. LaCour, who is conducting the probe along with his first assistant, Gene S. Palmisano and Michael Epstein, a special attorney for the Department of Justice from Washington, would not say who will appear at Wednesday's session.

CHICAGO TESTIMONY The jury is investigating allegations that Edward G. Partin, Baton Rouge Teamster Union officer, had been approached by certain persons in an effort to have him change his testimony which was instrumental in sending Hoffa to the federal penitentiary in Lewisburg, Pa.

Strate was convicted along with Hoffa of conspiracy and fraud in another case in 1964 in Chicago.

The judge testified that Baldwin arranged a meeting between Strate and Sheridan.

After his appearance before the grand jury Tuesday, Sheridan said that his meeting with Strate came after Judge O'Hara told him that he had information that would be "very helpful" concerning the Garrison investigation.

"I did not know that Strate would be at the meeting. Strate offered me Pershing Gervais, I told him before we went any farther I wanted to know what he wanted from me.

"He told me he wanted Hoffa out of jail. He wanted me to give him information about bugging and wire tapping and Chattanooga (where Hoffa was Sheridan was an investigator tried for jury tampering),
