## JURY CALLS BROWN IN N.O. CRIME PROBE

Subpena Served Directing Governor to Appear

The name of J. Marshall Brown, Democratic national committeeman from Louisiana, was added to the list of those scheduled to appear before the Orleans Parish Grand Jury in its probe of organized crime.

A subpena was issued for him by the District Attorney's Of-

fice Wednesday.

Deputies of Criminal Sheriff Louis A. Heyd Jr. said Brown's subpena, which directs him to appear at 11 a.m. Thursday, was served personally in New Orleans. Earlier Wednesday, chief

deputy's assistant Barney Kilbride served a subpena directing Gov. John J. McKeithen to appear at 2 p. m. Thursday on William V. Redmann, executive counsel to the governor, in Baton Rouge.

Previously Jefferson Parish rackets figure Carlos Marcello and two of his brothers, Samuel and Peter, were also subpensed.

to appear Thursday.

Meanwhile Wednesday, East Baton Rouge District Attorney Sargent Pitcher, conducting his own crime investigation, said in Chicago that he has met with "tremendous success and accomplishments" on a trip to gather information about organized crime.

## YOUNG ACCOMPANIES

Pitcher, who said details will be made public at the proper time, was accompanied to Chicago by Aubrey Young, a former aide to McKeithen.

Young's testimony before the East Baton Rouge Grand Jury has led to one indictment already in that jury's investigation of organized crime.

McKeithen was attending the Washington Parish Fair in Franklinton when his subpena was served. Redmann said the governor would have appeared on invitation without the subpena.

District Attorney Jim Garri-son Tuesday first had invited the governor to appear in New

Orleans, then subpensed him. Garrison, when asked why he issued the subpena, said, "Orig-

inally, I was following protocol and then I decided this is no time for protocol.

"We want to find out what these allegations of organized crime are all about and, so far, nobody seems to know except what they read in Life Maga-

"We are going to call everybody we think can shed some light on this thing . . . if we have to we'll call the ambassador to the United Nations."

Also Wednesday the head of the State Police announced that the identity of a person who made a telephone call threatening McKeithen's life is known.

Col. Thomas Burbank described the man as a mental case and said that he is from New Orleans. Police have the man under observation. Burbank said.

Gordon Novel, who has figured prominently in Garrison's Kennedy death plot, said Wednesday he has offered to testify before the East Baton Rouge jury on organized crime provided immunity from Garrison be guaranteed.

## GOING TO OHIO

Pitcher had said he was going to go to Columbus, Ohio, to ask Novel about his claim of having information. He planned to go on to Ohio from Chicago.

Novel said he sent a wire to Pitcher. The telegram follows:

"Dear Sir: Upon consulting

with my noted attorney, Mr. Jerry Weiner of Columbus, Ohio, pertaining to your recent statements relative to my 'putting up or shutting up' I hereby formally offer to come to Baton Rouge, La., immediately to testify about matters relative to my recent press state-ment and your belated investigation and will furnish facts. figures, documents, plans, re-cordings, etc., about these matters providing I can be granted complete immunity within the entire state of Louisiana, including any and all parishes where I am currently being fraudently prosecuted for such time as is necessary to render the data and testimony before your grand jury and am per-mitted to return at my free will to the state of Ohie without any further persecution and political harassment.

"Please forward Mr. Weiner the necessary immunity docu-ments or shut up. Sincerely, Gordon Novel."

'PLEDGE OF ACCORD' Meanwhile, Pitcher had sent a telegram to Weiner in Colum-

bus, offering to meet Novel anywhere in the nation and examine Novel's information.

"Your refusal to accept this reasonable request can only be interpreted as an admission on your part that you have attempted to sensationalize fictitious or nonexistent evidence or to obtain immunity for yourself from crimes best known to yourself," Pitcher said

Pitcher told Novel if his information was of value he was confident Gov. McKeithen, Garrison and other state prosecutors would honor his request for immunity from arrest while in Louisiana to testify before the Baton Rouge Grand Jury.

Pitcher said Garrison had been advised of the reply and had given his "complete pledge of cooperation and ac-cord,"

The East Baton Rouge jury, which met Wednesday, was expected to recess until Pitcher returns, probably Thursday or Friday. Telephone company of-ficials were expected to take records in connection with testimony by Young to the jury.

"All I have to say is that the trip to Chicago has been narked with tremendous suc-

cess and accompusaments, Pitcher said. "The details and significance of our findings will ne revealed later, when the ime is appropriate."

He flatly stated, "when it comes out, it will be real good."

His Chicago information involves many more people in the investigation, but he was unable to disclose who and how many at that time, Pitcher said.
