Congratulations on your new book. How about sending me another copy of the second page of your news article, as you cut off part of the last column.

To try to answer your questions, I think that my book **HIGH TREASON 2** makes clear that the body was *not* stolen or altered. Weisberg would agree, but we disagree on the rest. The body theft and alteration is a product of David Lifton's distortions and omissions of the facts. Why alter the body when you can simply fake the pictures and X-rays? Weisberg would say that the material is not faked either because why take the risk of being found out? This is sophistry. Nobody found it out, at least not yet, but I've come close to exposing this to be what happened. I am the only one who has taken a strong stand that all the evidence is fake. I think my published research proves it.

Groden thinks that the body was altered, but he also took over our thought in 1977 that the pictures of the body had to be altered. That is the point of the book I published in 1989 (**HIGH TREASON 1**). His thinking has always been muddled, because he mouths whatever he hears at the moment that sounds good, as long as he can take it over and control things. He has many conflicts.

You may be aware that Groden is being exposed as misrepresenting his credentials or the lack of them in the O.J. Simpson case. He sure fooled me and the rest of us.

Before you are quick to call me, Harold, or anyone else your friend, you need to know a lot more about the people in this case. There are high stakes, and the case and the evidence are politicised. Know what that means? Harold has done more to damage this case, in my opinion, than anyone else, including both Groden and Lifton, two of the biggest fakers in all of history.

When you get **KILLING THE TRUTH**, turn to the chapter called "Treason and the Smoke Screen" and study it closely. Its about some of the researchers, though I had to pull my punches, and the subject really requires a whole book itself.

There are very vicious fights between the leading researchers and it is game played for blood and its kill-or-be-killed. Some of these people try to ruin the lives of other competitors, often with terrible lies behind their back. You don't need to be a target, because you too will become one.

My advice to you is to stay away from Dallas. I almost always go there with a team of police officers from my city. How do you know some redneck won't take a shot at you? You'll never be the target I, a famous writer on the case, am, but you might get hurt anyway. For what? What can you find there that's new?

My latest published book (No. #4—I have written a fifth just now), **KILLING KENNEDY and the Hoax of the Century**, is the road map of the current secret investigation

in Washington by the ARRB. They have had all the autopsy doctors in for interviews, and they seized Groden's materials. You will be hearing much more about this later this year. Maybe quite soon.

Be super careful in Dallas, as the former cops there run an operation on out of towners. Don't you know that some of them were part of the plot? Who put you in touch with Leavelle? Things can happen to you if you get too close. We had some real first class wrecking operations run on us. What makes you think Leavelle can be trusted? He is tight with one of the leading cover-up artists among us. Guess who that might be?

Harold never understood the case. He is in it to tell us that the evidence is authentic and not faked.

The entire case is fake. All the evidence is fake, including Groden's Zapruder film. If you understand the conspiracy and how it worked, then you will understand that, and if you grasp, from the secret documents (HSCA interviews of the autopsy doctors) published in my last book, **KILLING KENNEDY** that the autopsy pictures are inaccurate, then you will begin to understand the truth.

How did you get my address? From Harold? Are you reporting this to him? To anyone? Why would you go to see him?

You say that sometimes you don't understand Harold! *Nobody* can understand him because he speaks and writes in riddles and his thinking and writing is muddled. I used to admire him until I examined closely his "work" and what he is all about.

The message is that we are told whom to respect: "Respected Researcher Harold W...." or "So and So" and that is who we think has the answers. It is all a mind control operation run by intelligence professionals--which Harold is. So is Leavelle in his way. You are being put on the "Circuit" and they will give you the tour and run you ragged until your money and your parent's money and your girlfriend's money and love all run out. You will be all tired out when you need to take care of business.


Then you will be all tired out and you got nowhere. Just a big fish in a small pond or even a small fish in a big pond.
