

TRIP TO DALLAS

THE PROPOSED TRIP TO DALLAS CAN BE OF GREAT BENEFIT TO US IF WE PLAN IT PROPERLY AND SET REASONABLE GOALS. I HAVE PREPARED A LIST OF VARIOUS TASKS THAT SHOULD ASSIST US IN OUR PROJECT AND I HAVE MADE ECONOMICS A KEY FACTOR IN SETTING OUR GOALS.

I AM HOPING THAT I CAN DEPART BALTIMORE ON 8 JANUARY 1991 AND RETURN ON THE 18th. THIS IS SUBJECT TO YOUR APPROVAL. MY REASONS FOR WAITING UNTIL THEN ARE ENUMERATED BELOW:

- 5) I WILL HAVE MORE TIME TO PREPARE FOR THE TRIP.

TASKS THAT NEED TO BE ACCOMPLISHED

- 1) MEET WITH JAMES DEAVELLE AND OBTAIN TWO LASER COPIES OF HIS 1963 DALLAS POLICE YEARBOOK. THIS IS AN INVALUABLE RESEARCH TOOL THAT IS UNAVAILABLE TO RESEARCHERS.
- 2) CHECK THE DALLAS AND FORT WORTH HOSPITALS TO SEE IF THEY CAN PROVIDE US WITH THE NAME OF KAREN CARLIN'S BABY BOY WHO WAS BORN ON 23 APRIL 1963.
- 3) ATTEMPT TO VERIFY THE EXISTENCE OF THE PHOTOGRAPHS THAT WERE TAKEN IN THE EMERGENCY ROOM OF PARKLAND HOSPITAL. IF THEY ARE LOCATED THEN AN EFFORT SHOULD BE MADE TO PURCHASE THEM.
- 4) EXAMINE GARY SHAW'S FILES ON "LITTLE LYNN".
- 5) GO TO THE FORT WORTH POLICE AND TRY TO OBTAIN A COPY OF KAREN CARLIN'S MUGSHOT AND ARREST RECORD.

- 6) OBTAIN A CURRENT DALLAS RESIDENTIAL AND COMMERCIAL TELEPHONE DIRECTORY.
- 7) OBTAIN A CURRENT FORT WORTH RESIDENTIAL AND COMERCIAL PHONE DIRECTORY.
- 8) ~~SEE WHAT ADDRESSES I CAN GET FROM GARY SHAW AND LARRY HOWARD.~~
- 9) SEE IF THE AGVA STILL HAS AN OFFICE IN DALLAS. IF SO THEN I SEE IF THEY HAVE RECORDS ON:

 - 2) NANCY POWELL.....TAMMI TRUE
 - 3) WILLIAM CROWE.....BILLY DEMAR

- 10) ~~SEE IF I CAN LOCATE ALERED J. JACKSON JR WHO WAS THE ATTORNEY WHO REPRESENTED KAREN AND BRUCE CARLIN AT THE HEARINGS BEFORE THE WARREN COMMISSION.~~
- 11) MEET WITH BUELL WESLEY FRAZIER AND SET UP AN INTERVIEW FOR YOU. PRIOR TO THE TRIP I WILL PREPARE A BRIEFING PACKET ON HIM.
- 12) I SHOULD SPEND TWO DAYS WITH GARY SHAW AND LARRY HOWARD SO I CAN POSSIBLY LEARN WHAT IS GOING ON IN DALLAS.
- 13) EXAMINE GARY SHAW'S PRINTED COPY OF THE FOURTEEN VOLUMES OF "THE TEXAS ATTORNEY GENERAL'S INVESTIGATION INTO THE ASSASSINATION OF PRESIDENT KENNEDY". I ALREADY SPOKE TO GARY SHAW ABOUT THE REPORT AND HE STATED THAT HE GAVE A SET (ON MICRO-FILM) TO THE ASSASSINATION ARCHIVES AND THAT IF YOU ASK BUD FENSTERWALD HE MAY SEND IT OUT TO BE RUN OFF IN HARD COPY.
- 14) EXAMINE THE DAL-TEX BUILDING. THIS IS THE SAME BUILDING THAT ABRAHAM ZAPRUDER WORKED IN AND WHERE TWO POSSIBLE SNIPERS ARE VISIBLE IN THE ALTGENS PHOTOGRAPH.
- 15) INTERVIEW THE CARE TAKERS OF ROSEHILL CEMETARY WHERE OSWALD IS BURIED SO THAT I CAN SEE WHAT INFORMATION THEY KNOW ABOUT HIS EXHUMATION AND HIS BODY BEING MOVED ABOUT. ALSO I WILL GET A COPY OF ALL OF THEIR RECORDS FOR YOU TO EXAMINE.
- 16) I WILL PHOTOGRAPH AS MUCH AS POSSIBLE. WE NEED TO LIST WHAT YOU WOULD LIKE TO HAVE PHOTO'S OF PRIOR TO LEAVING.
- 17) SEE IF THE O'NEAL FUNERAL HOME STILL EXISTS AND IF THEY HAVE MAINTAINED THE RECORDS OF THEIR AMBULANCE RUNS FROM 22-24 NOVEMBER 1963. ALSO, SEE IF THEY HAVE KEPT RECORDS OF ALL

OF THEIR PAST EMPLOYEE'S. IN PARTICULAR I AM INTERESTED IN A GUY THAT GUS TOLD ME ABOUT WHO KICKED A BULLET OUT OF THE AMBULANCE THAT TIPPIT RODE IN.

- 18) GET THREE PRINTS AND THREE NEGATIVES OF PHOTOGRAPHS OF KAREN CARLIN FOR SHOWING IN TENNESSEE IN FEBRUARY.
- 19) CHECK WITH THE REAL ESTATE LICENSING BUREAU AND SEE IF THEY HAVE RECORDS ON NAPOLEON J. DANIELS. HE REPORTEDLY HAD HIS OWN REAL ESTATE AGENCY AFTER THE ASSASSINATION.
- 20) LOOK AT LARRY HOWARD'S CONTRACTS AND SEE IF THEY HAVE ANY INFORMATION THAT CAN IDENTIFY THE GIRLS.
- 21) MEET WITH SHARI ANGEL (WALLY WESTON'S WIFE) AND GET WHATEVER BIOGRAPHICAL INFORMATION THAT I CAN.
- 22) CHECK COMMERCE STREET AND SEE IF ANY OF THE CLUBS ARE STILL OPEN.
- 23) SEE IF THE LIQUOR BOARD HAS ANY RECORDS ON THE CAROUSEL CLUB OR ON JACK RUBY.
- 24) INTERVIEW L. C. GRAVES.
- 25) FIND ALAN SWEATTS SON AND SEE IF HE HAS ALAN'S PICTURES.
- 26) TRADE SOME BALTIMORE CITY POLICE PATCHES FOR DALLAS POLICE PATCHES, DALLAS COUNTY SHERIFFS PATCHES, AND FORT WORTH POLICE PATCHES.
- 27) SEE IF WESLEY FRAZIER WILL GIVE ME LINNIE MAE RANDLE'S DATE OF BIRTH OR HER CURRENT ADDRESS.
- 28) GET XEROX COPIES OF LEAVELLE'S ORIGINAL NOTES. NO ONE ELSE HAS THESE. (AND I MEAN NO ONE...NOT LIPTON..NOT GRODEN...NOT WEISBERG...NOT THE NATIONAL ARCHIVES) THEY ARE OF GREAT VALUE BECAUSE THEY WERE MADE 22-26 NOVEMBER 1963.
- 29) XEROX PAGES OUT OF GARY SHAW'S CRISSCROSS DIRECTORY.


